#### MEMORIAL PARK

- 1. March 7, 1972 (Arbor Day) marked the formal dedication of to 4.76 acres (adjoining Honor Oak Subdividion) given to Sutter County by Howard and Norma Harter for a Memorial Park, honoring the pioneers and veterans of the locality.
- 2. Since the County had no funds for its development, the Sutt-County Historical Society accepted the responsibility for its development by way of gift from the citizenry wishing to avail themselves of this opportunity to honor loved ones by way of creating a beautiful park of trees, shrubs, lawns, picnic area etc., to be cherished for all time.
- 3. Landscape plans were made, and over 200 trees are already growing there, as a result of gifts from donors thus far, and further planting and development is proceeding as weather permits, and gifts are received.

## COMMUNITY MEMORIAL MUSUEM

- 1. October 1, 1973, Howard and Norma Harter gave \$100,000 to the County for the purpose of building a MUSEUM. With the Board of Supervisors acting on behalf of the County, the Community Memorial Trust Fund was established.
- 2. Aided by a gift of \$15,000 from Gilbert Williamson, the Trustees of the Fund purchased the approximate acre bounding the Park Site on the south from Wilfred L. and Georgia Williams, for \$20,000. The Williams, in turn, made a gift of 2,500 to the Fund. Thus, the park was opened to frontage on Butte House Road.

- 3. With the architectural plans near acceptance, bids will soor go out for the contracting, and work will begin on off-site development.
- 4. Upon completion of the building, the County shall assume full responsibility for the operation and maintenance of the MUSEUM, including provision for the employment of a Curator, as well as for the operation and maintenance of the Park after the current obligation of the Sutter County Historical Society has expired.

Now is the time for your participation in the memorable project, -that you may take pride in knowing you took part in its making - - that you may have the satisfaction of knowing that you're helping to preserve for your children, and for theirs, much that is precious to us all.

# LINDA FROM EARLY DAYS Submitted by Jack Dunning

The only living inabitants of the valley before 1839 were the various tribes of Indians living in scattered villages or rancherios.

Captain John Sutter, in 1839 received a grant of land on the east bank of the Sacramento River. This grant extended as far north as the Yuba River. He established a residence and trading post on high ground near the south bank of the American River, and called it New Helvetia, but it scon became known as Sutter's Fort.

Prior to the arrival of Sutter the only white people were the occasional trapper and explorer. The famous Jededish Smithirst was in the valley in 1825.

Nicolaus Allgeier in 1842 was settled by Sutter at a site on the east bank of the Feather which later became known as Nicolaus. That same year the Hock Farm was established by Sutter on the west bank of the Feather River not far below the mouth of the Yuba River. Shortly afterward Theodore Cordu was given a lease on some land on the east bank of the Feather River and north of the Yuba River.

Cordua soon built an adobe house and established a trading post. This was called New Mechlenburg by Sutter after the birdlace of Cordua in Germany. Cordua later obtained a grant of land to the east of his lease which extended from the Yuba Rive to the Honcut Creek. He raised cattle and horses and later began raising produce which was shipped as far as the Sandwhich Islands (Hawaii).

In 1844, Don Pablo Gutteriez received a grant of land along the north bank of the Bear River and built an adobe house there. Shortly afterward he was killed and his land was sold at auction by Magistrate Sutter to William Johnson and Sebastia Keyser. This became known as Johnson's Crossing and later Johnson's Rancho.

Sailor Jack Smith received a grant of land from Sutter, a tract three miles along the south bank to the Yuba River above Marysville. He soon built an adobe house on his farm, on which he was raising cattle and horses.

In 1846, George Patterson purchased one mile of the Smith grant. In that same year Michael Nye bought land to the west of the Smith holdings. Patterson's land was known as Sutter's Gardens.

Baptiste Roulle, who had discovered gold in the Los Angele area settled near Sutter's Gardens on the east bank of the Feat River.

John Bidwell, founder of Chico, Michael Nye, and Capt. Chas Weber, founder of Stockton, were all members of the Bartleson Party, the first wagon train to cross the plains. They had bo abondon the wagons in Nevada and arrived in California in November of 1841.

During 1843 and 1844, Bidwell was in charge of the Hock Farm for Sutter. He build an adobe house there and later the iron building. He supervised the work of a large number of Indians who worked on the ranch. At that time Sutter had about 5,000 head of cattle and 1,200 horses on the ranch.

In 1847 a number of survivors of the Donner Party settled in the vicinity of Sutter's Gardens in Linda. Among them were members of the Murphy family.

Shortly after gold was discovered by Marshall at Coloma, Jonas Spect found gold on a bar of the Yuba River near Timbucto At about the same time Michael Nye found gold in the River near the mouth of Dry Creek.

In 1849, Theodore Cordua sold half his holdings on the north bank of the Yuba River to Charles Covillaud. The other half was shortly afterward sold to Michael Nye and William Foster. The name of the settlement was then changed to Nye's Ranch. Nye and Foster were married to sisters of Mrs. Covillau the former Mary Murphy, who had been married and dovorced from Wm. Johnson of Johnson's Rancho. In the same year John Rose purchased the holdings of Michael Nye and Theodore Sicard on the south side of the Yuba River (Linda). In September, Nye and Foster sold their interest in Nye's Ranch to Charles Covillaud, who in turn sold a half interest to J.M. Ramirez and J. Sampson, and a little later a fourth interest to Theodor Sicard. By this time Mr. Simpson had established a crossing and built a ferry on the Yuba River about two miles above Nye's Ranch. This was known as Simpson's Crossing.

In October of 1849, the Kennebec Company of Gardiner, Main arrived at Nye's Ranch where they built a house. The men of this company became very active in the settlement of Yuba Count In December of 1849, Covillaud and his partner had the ranch surveyed and a town laid out. The town was called at that time Yubaville. A number of lots were sold and a few buildings and some tents were erected. A store was built by a Mr. Osburne on Front Street (First Street, Marysville). In a short while the name of the city was changed to Marysville in honor of Mrs. Covillaud. The surveying and the work of laying out the streets was done by a Mr. A. LePlongeon, who gave it the name Yubaville. Yubaville was California's first planned city and was patterned after Paris, France.

In January of 1850, Stephan J. Field, an attorney from New York, arrived in Marysville. At the first election of the new city he was elected alcalde or mayor of Marysville. Field sig ned up for a number of the lots of the city and did much to promote the sale of lots. He later became Chief Justice of the Supreme Court of the U.S.

The Linda Company arrived at the Rose Ranch on the south Bank of the Yuba River in December of 1849. They settled near the adobe built by Theodore Sicard earlier. This company had arrived at Sutter's Fort by the sailing vessel Linda, where they built a small steamer which they named Linda. This steamer was the first to run on the Feather and Yuba Rivers. In the spring of 1850, the Linda Company laid out a town on the south bank of the Yuba River about three miles above Marysiille. They called their town Linda, and built a number of houses. (The site was somewhere north of the present Peach Tree Country Club). At

about the same time the Kennebec Company laid out a town on the east bank of the Feather River below the mouth of the Yuba River. Their town was called Eliza, named after the daughter of Capt. John Sutter. Both town of Linda and Eliza lasted only a short time, Eliza a few months and Linda two or three years. The sites are now covered by debris from the hydraulic mining. Until about 50 years ago (1920) some of the tops of the chimneys which were made of brick could be seen at the sit. of Linda.

The Linda School was established in 1855 with 36 pupils. It was located on the trail from Marysville of Johnson's Panch and near the present site of Yuba College dormitories. On October 10, 1856, Linda Township was formed by the Yuba County Board of Supervisors. At about this time a Mr. Teegarden planted extensive orchards and gardens on the rout from Marysville to Simpson's Crossing. (Yuba Dam Ranch)

After a bridge was built at Simpson's Crossing in 1861, a Mr. Shelton built a road house on the south bank of the river at the bridge, and 1870 the Dunning Ranch was established about one-half mile from Shelton's place. These two establishments were popular stopping places for the teamsters hauling freight from Marysville to the "Northern Mines", and to Nevada via the town of Spenceville, Nevada County.

The earliest settlers of Linda mainly raised cattle and horses, but shortly they began raising grain in a large way. The Buckeye Flour Mill was built in Marysville and flour products from the mill were shipped from it all over the Pacific Ocean. Two of the main purchasers were China and Australia. The old mill building was town down a few years ago to make way for improvements at the P.G. & E. shops.

The California and Oregon Railroad was built through Lind into Marysvillle in 1869, later becoming a part of the Southern Pacific System. The Western Pacific Railroad was built in 1910

After the great flood of 1875, levees were built along the south side of the Yuba River, cutting off the great bend of the river which ran as far south as the present North Beale Road. The Lowe and Stephenson residences together with a number of others are built on land which at one time wss the original course of the Yuba River.

In 1907 and again in 1909, the Linda area was flooded. The water was five feet deep at the present intersection of North Beale and Hammonton Roads. In 1910, reconstruction of the levees and reclamation of the land began. At about this time Reclamation D District 784 was formed. The area now known as West Linda was mostly overfloe land and covered with willow and cottonwoods. The present site of the Stephenson Ranch and Speckerts Mill were all covered with large trees and brush. Reclamation of this area began after World War One. At about this time the Bull Tract, West Linda, began to be settled. A grocery store was built at the Four Corners (Hammonton R d and Lindhurst Ave.) The first paved road was built at about this time from Marysville to the "Four Corners".

At about this time the Dunning Ranch was subdivided. Up to this time there were no more than 6 or 8 houses in all of Linda. In 1928, the one room Linda School was abandoned the a new two room school was built at the present site on Dunning Avenue.

During the period from 1930 to 1940 a number of houses were built in the Linda District. In 1940 construction of Camp Beale was egun and North Beale Road was built through the area. This activity brought about a lot more develoment.

In 1948 the Linda Fire District was formed.

In 1955 the Linda Water District was formed. This broug about much more development and after the installation of the sanitary system, Yuba College was located in the district as well as much more.

## PASSED TO GREAT BEYOND Aller Chapman Robertany Chapman

Daily Torning Union, Nevada City, Calif., Friday, 9 July

1897.

Passed to Great Beyond, Dr. Allen Chapman Joins The Silent

Majority.

Nevada City has lost another of her old pioneers. At 5:35 O'clock last evening Dr. Allen Chapman breathed his last at his home on Sacramento street. Every effort was made to prolong his life but without avail. Dr. Chapman was taken ill some two years ago and although at times He seemed to be on a fair road to recovery he was never strong. He was injure in a runaway accident at Virginia City, the effects of which, coupled with la grippe, brought his life to an end.

Deceased was an honest man, of a jovial dispostion and a loving father and husband. He was known to nearly all of our people and his death is greatly deplored. He came to Nevada City in 1865 and began the practice of his profession, that of a dentist in which he was engaged until 1875, when he removed to Virginia City. Since then he made frequent tri here, but was forced to retire a few years ago, since which time he has visited many resorts, hoping to regain his health.

A few months ago he went to San Diego and for a time

seemed to rally, but on Monday he was taken down again. doctor was a public spirited citizen and took great interest in the welfare of the county seat, being interested in mining and other properties. He was a prominent Mason, being a member of Nevada Lodge of Masons and of Nevada Commandery; Knights Templar. In 1861 he was married to Miss Nellie E. Pooler in this city and the result of the union was two sons-Dr. S.A. Chapman of Virginia City and Dr. C.W. Chapman of this city. who besides his wife, Dr. W.E. Chapman, survive him. He was a native of New York and aged 70 years, 8 months, and 24 days.

The funeral will take place from the family residence on

Sacramento street tomorrow afternoon at 1 o'clock.

Services will be held at Armory hall at 2'oclock under the auspices of the Masonic fraternity.

Daily Evening Herald, Nevada City, Calif., Friday, July 9, 1897. 'A Pioneer Gone, Death of Dr. Allen Chapman, An Old Resident.'

Dr. A. Chapman, whose illness has benn noted in these columns from time to time, passed away last evening at 5:35, at his home on Sacramento Street. He had been ailing for a year or two-in fact had never been well since he had the grippe, at Virginia City several years ago.

Dr. Chapman was a native of New York, aged 70 years, 7 months, and 24 days at the time of his death. He leaves a wife and two sons, the latter being Dr. C.W. Chapman of this city and Dr. S. A. Chapman of Virginia City, Nev.

Deceased was a pioneer of Nevada County. He came here in '56 and engaged in farming on what is still known as Chapman Ranch, two or three miles west of Nevada City. At the same time he practiced his profession, dentistry, and later on he taught his wife and sons the art, and they are still practicing. In '75 he went to Virginia City, where he built up a fine practice and where he remained until two or three years ago.

He returned to Nevada City in poor health, and last winter went to San Diego hoping to benefit his health, but at his time of life recovery was impossible and in the spring he returned to this city to event the inevitable and

to this city to await the inevitable end.

The Doctor was a man of rare attainments and of jovial disposition, and made friends everywhere. He was public spirited, and invested money in mining enterprises. A good man has gone. Peace to his ashes.

The funeral of the late Dr. Allen Chapman was held on Sunday afternoon, with services at Armory hall, where hundreds of people assembled to pay their last respects to their old friend and neighbor. The knights of Templar and A.L. of H. turned out, the deceased being a member of those societies.

The pall-bearers were chosen from Nevada Commandery, K.T., as follows: John T. Morgan, M.L. Marsh, W.D. Long, Wm. Floyd,

D. Marsh, Wm. Holmes.

At the Armory the coffin, which was a massive state casket, rested on a stand surrounded by beautiful floral pieces. A choir directed by Prof. J.R. Davis sang several beautiful hymns, and Rev. J. Sims preached the funeral sermon, dwelling upon the good qualities of the deceased and relating some of the ups and downs he had experienced during his long residence here. The day being excessively hot, the pastor made his discourse brief, and at its conclusion the funeral cortege took its winding way to Pine Grove Cemetery, headed by Goyne's Band. A long line of carriage: followed the bier to its last resting place.

At the cemetery the Knights performed their beautiful funeral ceremony, the band played a dirge, and all that was mortal of Allen Chapman was consigned to the grave. It was an

impressive ceremony.

Nevada City, Calif., Monday, July 12, 1897

DR. CHAPMAN LAID TO REST Impressive Ceremonies by Knights Templar. A Sketch of the Deceased Pioneer's Early-Time Struggles and Triumphs. (continued next page) -8The funeral of the late Dr. Allen Chapman took place from Armory Hall yesterday afternoon at 2 o'clock under the auspices of Nevada Commandery, Knights Templar, and was largely attended. The ceremonies were of an impressive character, and the singing by Trinity Episcopal choir, assisted by John Werry, basso, and Miss Edith Goyne as accompanist, was rendered in the most impressive manner. Two anthems were sung, and a solo by Prof. Davis entitled "Tired".

Rev. J. Sims of the Congregational Church made some very appropriate remarks, there being no regular sermon. Mr. Sims observed that Dr. Chapman was a typical American from boyhood. With the martyred Garfield he worked on the canal boat, and with the illustrious and immortal Lincoln he swung the axe and split the rail. When seventeen years of age he commenced the study of dentristry under the distinguished operator, Professor Foss. On graduating he became the partner of his preceptor and continued with him until he had accumulated the neat little sum of \$12,000, which in those days was considered, in the East, an ample fortune. But through hard work and close application his health became materially impaired. At this time the gold fever raged and throbbed in the hearts and veins of men generally, and the Doctor resolved to go to California, not so much in quest of the precious metal as in search of his accustomed health.

The reminiscences of his voyage to California and subsequently his journey from the lower counties to Nevada City, read like a historic romance. In the year 1856 he entered upon his profession in this city, when pine=pillared temples were more numerous than places of worship and when unsightly stumps occupied the sites where vine-mantled cottages now exist. He made money very rapidly and soon became interested in several mining claims and in the hotel busingss at Bear River, in cattle raising fruit raising and other important enterprises. And in every dollar he possessed his friends were permitted to share. He signed notes to the extent of over \$80,000, \$43,000 of which he paid out of his own pocket. In this financial difficulty he sacrificed his entire property, with the exception of his homestead, and was then in debt to the extent of \$16,000. His friends, the financiersof the community, advised him to go through bankruptcy, assuring him that the act was in the interest of men in his peculiar position. Such advise had no effect on the Doctor. He replied: "I went into it with my eyes open and assumed the responsibility. I will therefore pay it to the last cent. So he went down to the dividing river with a soul unstained. What grander legacy could he leave to wife and children than a record unsoiled by the breath of dishonesty?

Mr. Sims spoke of the Doctor being a man of genial disposition, that pessimists could not live in the atmosphere that environed him - as a man and devoted Mason, as being faithful to his friends and as being truly patriotic, remarking that his ancestors had distinguished themselves for heroism in the Revolutionary War. He concluded by referring to his religious views, which consisted in an abiding faith in the Supreme Architect of the universe, and the beautiful example le left to posterity.

The funeral cortege, headed by Goyne's Band proceeded to Pine Grove Cemetery, where the remains were laid to rest. The pall bearers were: William Holmes, William Floyd, John T.Morgan, W. D. Long, M.
