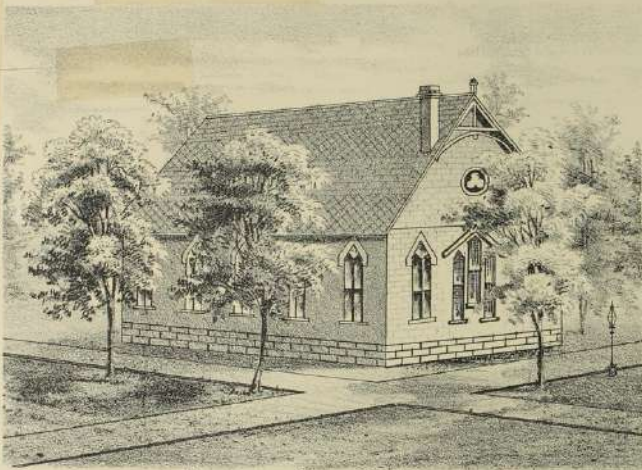
BIRDSEYE VIEW OF WAKEFIELD IN 1880.



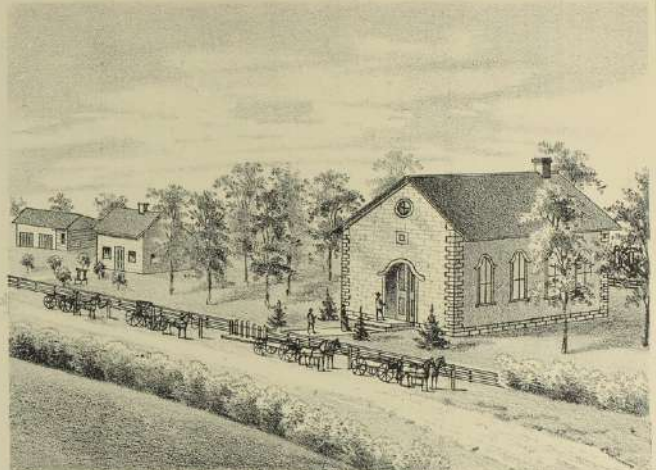
