The Biography of Greenzil Whiteside

Greenzil Whiteside was born June 18, 1816, in Kentucky, was married to Appie Cecelia Fincher of Tennessee, who died December 27, 1869, at the age of 47 years. To this union was born twelve children of which only one survives, Mrs. Joe Stallings of Coyville. The deceased children are Mary of Pasadena, Calif., Lucinda Whiteside, who married Vincent Atchison and Mrs. Laura Ogle, who is the only child surviving, and also the oldest grandchild. William Washington Whiteside married Olive Badgely. The surviving children are Edwin, Homer and Mrs. Paul Sutton; Samuel Whiteside married Mary Elizabeth Blackburn. The Children living are Appie Jane Hayden, Frank, Elmer and Ray; John Wilson Whiteside married Mary Million; the living are George, Arthur, Stella Laughten, Annie Chartier; Margaret Elvira Whiteside married Dick Owen and one child survives, Mrs. Rosa Peyton, and later she married Hopson Owens, the children are Mrs. Ella Drake, Mrs. Ollie Bates, Mrs. Maria Carr and Mrs. Alice Price; Nancy Louisa married Henry Barrett, the children are Ray, Roy and Roe, all are living; Harriett Jane married Christopher Fellows, only one child survives, William Fellows of Neodesha; James A. died at the age of 12 years; Joseph Andrew married Martha Lockard; Malvina Isabelle married Joseph Stallings, two daughters, Mrs. George Robertson and Mrs. Jim Marr are living; Miriam Olive married John Million and later married Allen Lockart; Laufetta Celia married Harry Forester, two children survive, John and Eva Calvert.

Our subject came to Kansas in 1866 from Sinclair County, Illinois and settled just east of Coyville on Greathouse creek now owned by Bill Gray and later moved to south of New Albany, where he purchased a large tract of land on Fall river where he resided and was prominent as a farmer until his death. The Osage Indians were here when he came. Little Bear being their Chief; he died and was buried northwest of Neodesha on Little Bear's Mound, before the Indians left for their new home in the Indian Territory. Lots of his men served in the Northern Army during the Civil War. At this time flour was \$12.50 a hundred and they had to go to Lawrence to get it. The first flour mill in the county was built one mile east of Coyville on the Verdigris by Keys and Scott Futhey in '68; they sold out to Oscar Coy and refuilt it at Neodesha. Afterwards he settled on Fall River; his son William, settled on the farm northeast

of him and John settled near Neodesha where Ray (or Doc) now wons. The rest of the children were scattered to other parts of the country. He helped to organize the First Baptist church in New Albany in 1866. It was chartered on April the 21st, 1883, by George Teeters, Robert Mooney, J. L. Toepfer, William Gains and Greenzil Whiteside. Uncle Green, as he was familiarly called, was a life-long Baptist. He was a conscientious and consistent Christian, generous and benevolent and greatly loved by all who knew him. Politically he was a staunch Democrat.

In 1871 he married Mrs. Maria Stallings, who was a good mother to his younger children. She was a devoted Methodist but they gave equally to both churches.

He had to have his clothes and shoes made to order as he was six and one-half feet tall.

He died on October 31, 1897 at the age of 82 years.

When the Winters and Baumans arrived from Ohio, they stopped at the Neodesha House. When they went to the dining room, here was a luscious looking amber liquid on the table. Grossmama drank down a glass of it, thinking it was a nice cool glass of beer, but it was her first introduction to iced tea. The Neodesha House was the center of social activities. All prominent visitors stopped here. Several came in anticipation of Neodesha becoming the County Seat.

On Christmas we youngsters went around to the stores, shouting 'Christmas Gift'and they would give us small presents. The Pierce Drug Store gave us small bottles of perfume.

From Mrs. Pingrey's journal

ZELLA WELDON CHICK

This family came to Wilson Co. and settled on a farm near Rest. Her father was Andrew Jackson Weldon (Jack) and her mother was Minerva Babbitt who had come from Decatur, Iowa to a farm near Pleasant Hill, Mo. Zella was born there in 1866 and about 1870 the land further west looked more alluring so they again took to the trail. The parents were married in 1865. Several families all related, came out together in a covered wagon train. They all took claims near Rest and Chanute.

One day Mr. Weldon was riding on his pony Lightning and a young fawn crossed his path. He took out after it and caught the little creature. He took it home and his children made a pet of it.

MRS. GEORGE COLLIER

Her maiden name was JOHNSON, Walden was her step-father. Her mother's family name was Clift, who came here in 1871. Mother's name was Mary Caroline Clift, father was a Norwegian named Lewis Johnson.

Mrs. Colliers grandfather Warren B. Clift and sons ran a black smith shop near where the Verdigris Bridge now stands near Mill Street and also ran a ferry across the Verdigris near their shop. Her uncle Jim Clift ran the ferry.

Her mothers brother Will Clift was going to stop overnight at the Bender farm. Someway things did not look right so he drove on. She does not know whether he had heard the rumors or not.

MRS. EDITH GRIMM 10-17-46

Her grandfather, Esquire Rue and family, came before there was a town. She says he bought the land now known as the Tanquary farm. The Osage Indians had a village southeast of the farm. Her mother Josephine Rue Leigh remembers the night Little Bear died/ When the mill was built on Fall River her father helped with the stone foundation. She says when Beulah Kile sold an additional ten feet for the post office she found that Squire Rue had once owned the lots but they never lived in town.

MRS. JOHN GRABNER Oct. 27, 1946

Her eldest sister, Frances Henderson married Frank Phelon, son of Alex Phelon, one of Neodesha's founders. ... The Hendersons came to Kansas in 1870/71 from Missouri. Another Phelon boy married one of the Snow girls. She says her sister and husband died within a day of each other from smallpox.

Our thanks go to Mr Leonard Montgomery for his following letter and information. It just proves that someone does read this quarterly.

'Your quarterly had reference to some of my family. I note a couple of things I think are in error:

In Vo. 3 No.2 Page 46, line 3 - you note a birth from the Neodesha Register of a son to Arthur Montgomery. Date 13 March 1910. I am that son, my birth certificate (delayed) says born 12 March 1910.

In Vol. 3 No 3, page 76 entry 14, gives the death and brief obituary of James Hutton, taken from WCC. It lists two marriages and 12 children. Family history has 15 children, the one not listed being Alma, Mary and Martha.

Order of birth from this marriage: to Charlotte Snyder and James Hutton, (she (b) 26 July, 1837, (M) 10 August, 1854 (d) 23 Sept. 1867 - Jacob (b) 16 August, 1855, John, (b) 17 July 1857, William, (b) 6 Feb. 1859, Rebecca (m Jefferson) (b) 16 Feb. 1861, Hattie (m) Wakefield, (b) 24 Jan. 1863, Manda Ella (m) Landon, (b) Sept. 6 1864, Alma (b) 6 Sept. 1867, (d) 30 Spt. 1867.

It is interesting to note that the only living son of William (James Hutton of Neodesha didn't know of this birth when I talked to him. And noting the death date of the mother and child, I assume that both deaths were complications from the birth, which was so common in these years.

James Hutton (above) married (2) Catherine Jay 9 April, 1868 (she (b) in Kentucky 14 June, 1845 (d) 27 Feb. 1915. Children this marriage, Mary E. (b) 11 Jan. 1869 (d) 29 Aug. 1870, Martha J. (b) 30 Mar. 1871 (d) 25 Jan. 1872, Elizabeth A. (b) 19 Nov. 1872 (m) Jetty, 23 Nov. 1890, Charles P. (b) 7 Jan. 1875, Robert W. (b) 23 Apr. 1877, Sarah E. (b) 20 Mar. 1879 (m) Scholes, Arthur B. (b) 4 August, 1881, Clara A., (b) 11 Aug. 1881 (m) Montgomery, my parents. These last two were twins.

James Hutton, the grandson, also didn't know of the first two births in this marriage. Perhaps the family just didn't talk of infant deaths.

Above information from Florence Fern Scholes, granddaughter of the elder James Hutton who has done much to trace this lineage. Also from Mrs. Arthur B. Hutton who had the family bible with these births.

All children of James Hutton are now dead. There is one living spouse.

I can furnish other limited information on this lineage to those interested.
