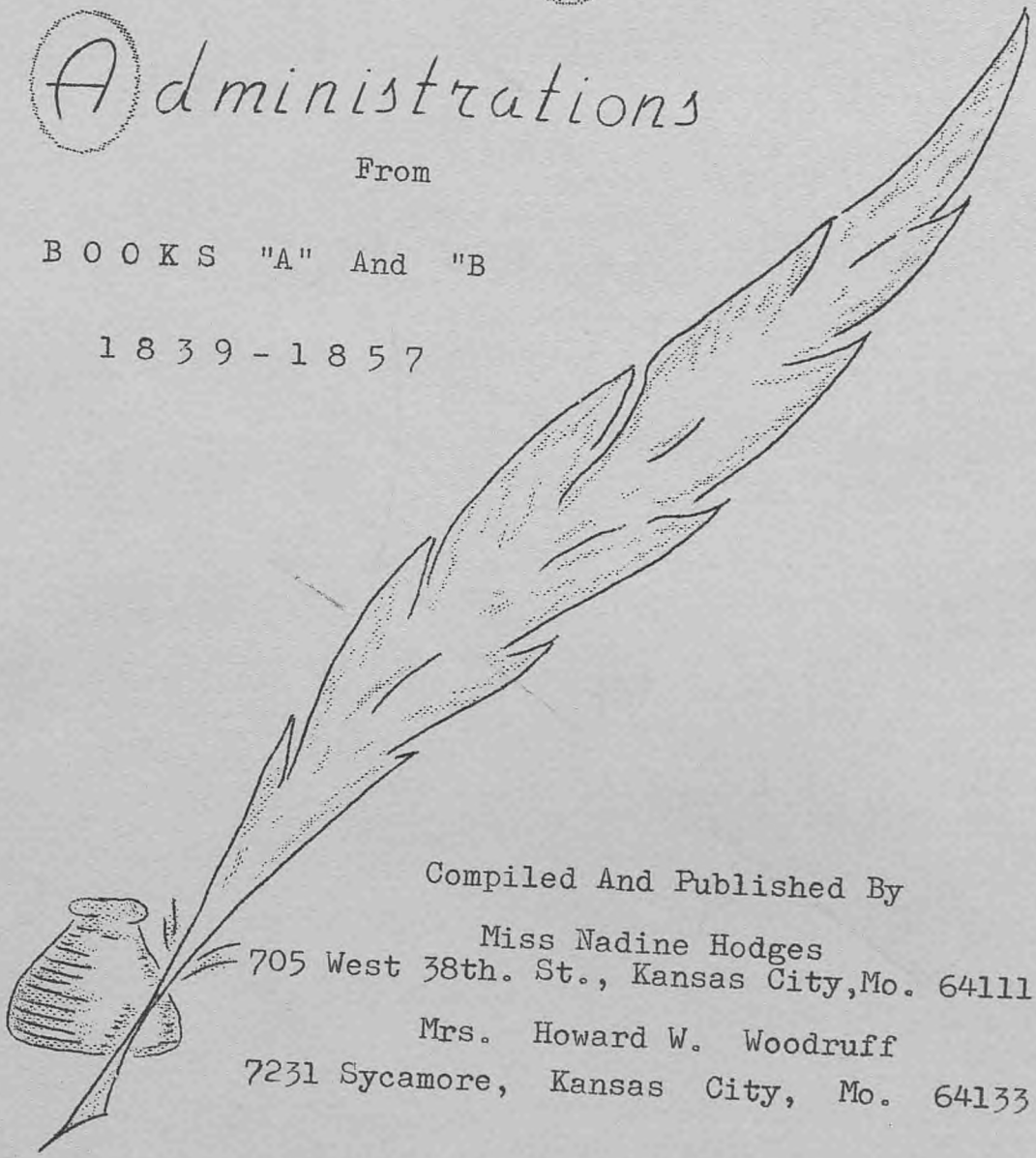

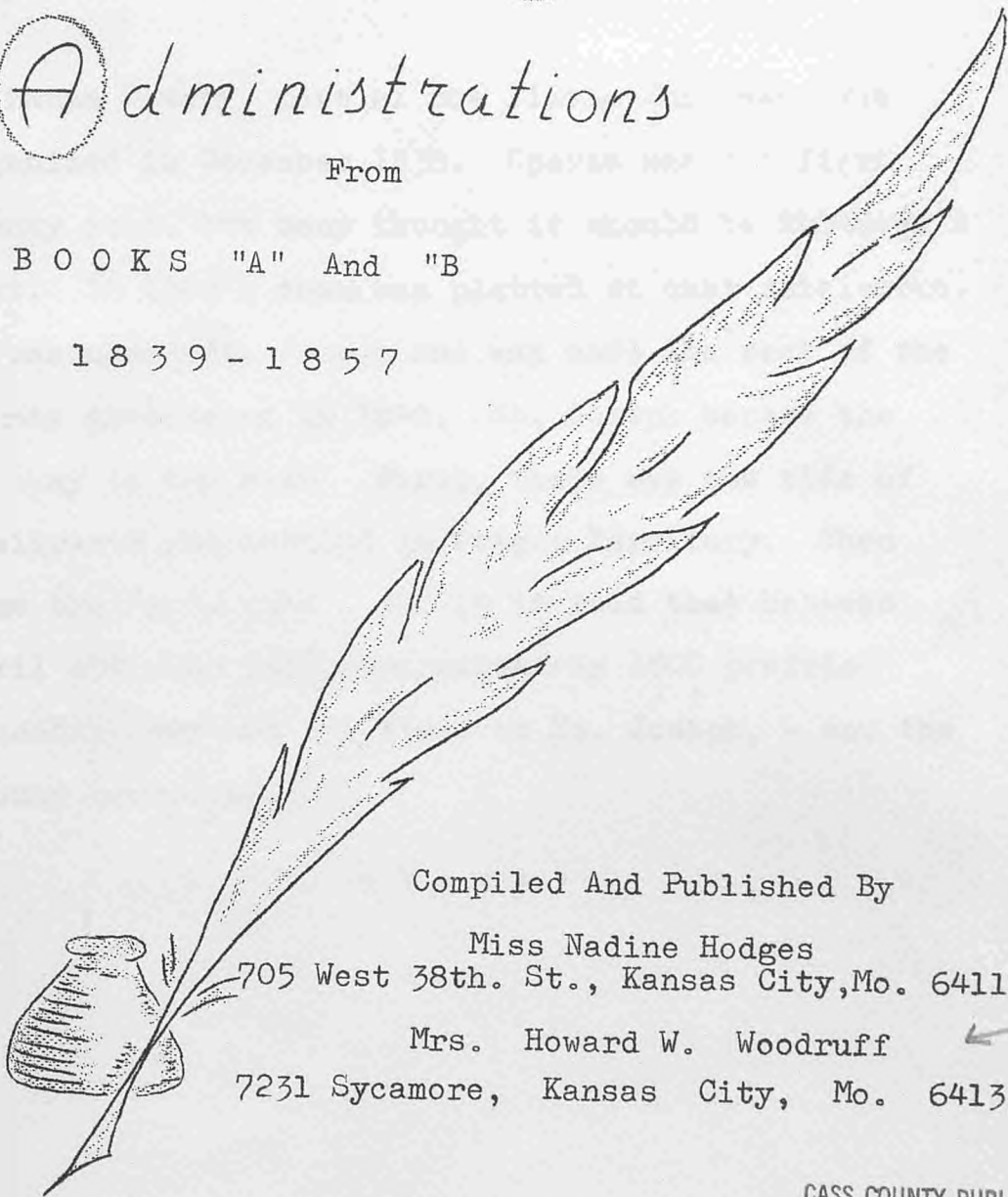

BUCHANAN COUNTY, MISSOURI

Buchanan County, part of the Platte Purchase, was organized in December 1838. Sparta was the first county seat, but many thought it should be Robidoux's Post. In 1843 a town was platted at that settlement. It was named St. Joseph and was made the seat of the county government in 1846. St. Joseph became the gateway to the west. First, there was the tide of immigrants who settled in Oregon Territory. Then came the "gold rush", and it is said that between April and June 1849, approximately 1500 prairie schooners crossed the river at St. Joseph, - and the county prospered.

The abstracts here presented are made from a microfilm copy, filmed by the compilers, of original books of Wills and Administrations in the Probate Office of the Buchanan County Court House at St. Joseph, Missouri.

All names of persons and places stated in the original records are included in these abstracts. If the place is not given, it is understood to be Buchanan County. Please bear in mind that the testator did not always list the names of all of his children in his will. It is obvious that many of the names were misspelled, however, the compilers have endeavored to maintain the original spelling in spite of the apparent errors.

The items of genealogical interest in the administrations are the date the administrator is appointed, the name of the administrator and names of the persons who post bond or security for his performance. Usually application for letters of administration is made within a few days after the death. Moreover, unless a public administrator is assigned by the court, often the administrators and the security (persons who post bond) are relatives, good friends or neighbors of the deceased. When there are minor heirs, there is often a record of the appointment of the guardian, usually a parent or relative of the children.

References to book & page number are as follows:

The page number given here is where the will record begins. Usually the record consists of several pages.

Many of our readers may not have access to an early history of Buchanan County, especially the one published in 1881 by the Union Historical Company at St. Joseph, which includes a chapter giving names of the earliest settlers in each township, and often stating where they lived before coming to Buchanan Co. Since this information might furnish a clue as to the whereabouts or origin of some ancestor, we are offering here a condensed version of the Chapter dealing with the first settlers in the various townships, some of whom moved on to other counties and states.

PLATTE TOWNSHIP

Judge Weston J. Everett of Clay County, but originally from Tenn. is said to have been the first permanent settler. He had visited the area in the fall of 1836 to select a location for his future home. He returned in February, 1837, and settled on land which had been occupied a short time by Absalom Enyard of Clay Co., Mo. Mr. Enyard having occupied the land before the country was open for settlement, he was dispossessed and driven out by U. S. forces. The land was purchased by Judge Everett. He was one of the most prominent citizens of this portion of Buchanan Co.

Absalom Munkers, a brother-in-law of Judge Everett, and a native of Tennessee, came to the same neighborhood in February 1837. They left Clay County together, but Munkers was detained on the road about a week. It is claimed that the wagons of these two gentlemen were the first to make tracks on the soil of Platte Township. Mr. Munkers was still living in 1881. His son, David, was the first white child born in the township, in April 1837.

Jackson Erickson, also a native of Tennessee, came from Ray County, Mo., in 1837. James Williams came in the year 1837, but later moved to California where he died. Old "Uncle Jack Huntsucker," as he was familiarly called, came from Tennessee in 1837. Peter Bledsoe, also, in 1837 and settled in the northern part of the township. He was still living in 1881.

William Cobb was one of the early settlers from Tennessee. Jesse Fletcher began to improve a farm in 1837, but moved to the Grand River country in Caldwell County and died there. John Fletcher, a son of Jesse, came with his brother-in-law, Asa Rockhold, in the spring of 1837. John Tobin, from Kentucky, was the only settler between the Fletcher and Rockhold places and Matney's Mill. He arrived in 1838. John Dryden settled the same year and settled about a mile north of the Platte County Line.

Thompson Burnham settled in the township in 1837; Charles Kennaird in 1838; Morris Pile in 1838 and was still living in 1881. James Anderson came about this same time. Dr. Samuel Trower arrived in 1838 from Kentucky and was the first physician to practice in Platte Township.

Platte Township, cont.

Nelson Witt came in the spring of 1838, also from Kentucky. He was the first Justice of the Peace (1839) in Platte Twp., and was at one time a County Judge. His son, Jackson Witt, was still living on the same place in 1881. Daniel Clark came in 1838 and his children remained in the vicinity where he settled. John Berryhill settled in the forks of Malden Creek in 1838. James Courtney bought the place which Jackson Erickson originally settled, on the latter's death, and lived in the township until his death in 1876 at age of 71 years, the oldest man in the township when he died.

James Fidler came in 1838. He was from Tennessee and died on the place he settled. The widow of his son, James, was living there in 1881. John G. Elliott said that his father, John Elliott, came from Kentucky in 1833 or 1834 and settled next to the Clinton County line. The country was still in possession of the Indians, so he moved over the line into Clinton County, but farmed in Platte Township.

John Commins, the father of Eli Commins, was also one of the early settlers and is said to have lived in the county several years before the Indians were removed.

The first mill built in the township was the Platte River Mill, or later called Matney's Mill. It was commenced in 1838 by Harrison Whitson, an old settler. Mr. Whitson operated it until 1843, when John Bretz became its owner. Judge John Rohan was the only merchant who sold goods in Platte Township. His store was on his farm.

JACKSON TOWNSHIP

Among the early settlers of this township was Pleasant Yates, who came in the spring of 1837, and was still living there in 1881, the year of publication of the book from which this account was taken. At the time of his arrival there were no white settlers within seven miles.

Isaac Farris settled in the northern part of the township in 1837. He was a native of Lincoln County, Kentucky, but had moved to Indiana and came to Platte Co., Mo., from there. His father, Isaac Farris, had been a pioneer of Kentucky.

Several families by the name of Holland settled at an early period to the south of Matney's Mill, and their descendants formed a considerable part of the early population of the locality. Levi Jackson, from Kentucky, was one of the early settlers of the township, and Judge Blevins was one of the pioneers, coming in 1837 or 1838. John Johnson came from North Carolina in 1838. Robert Prather came the same year from Kentucky and in 1881 was living in Atchison Co., Kansas. Phillip Walker came about the same time and was still living at age of over eighty years. Robert Wilson, of Ohio, came

about the same time. He died in 1865. The first to preach at the Mount Pleasant Church, Missionary Baptists, was Rev. Mathias Cline, who came in about 1844. John Ray came from N. C. in 1838; he died in 1857. G. W. Ray, his son, became a merchant of Arnoldsville. Also, in 1838, came Christopher Cunningham; his two sons William and John, moved to Kansas. Benjamin McCrary settled in the township in 1838 and died soon after the Civil War.

Charles Grable came to the township in 1840; still living in 1881. His brother, Anthony Grable, came with him. Eli Arnold came early, and died after the Civil War. William M. Matney became the sole proprietor of what is now known as Matney's mill, in 1857. This mill was then located in Jackson Township, on the Platte River, just opposite the point in Platte Township, where it was first erected in 1838.

CRAWFORD TOWNSHIP

William Fowler settled in Crawford Township in 1837; William Harrington, also, in 1837. Edward Davidson came from Illinois in 1837. Caleb Bailey settled there the same year. William Guinn came from Illinois in 1837 to Platte Co., but went on to California in 1846; William Lockhart, also, came from Illinois in 1837. Bartlett Curl, from Kentucky in 1837, went on to Oregon. James B. O'Toole was from Illinois in 1837; Harvey Jones, from North Carolina in 1837, and O. M. Spencer from Kentucky in 1837, but was living in Kansas in 1881. Others who came in 1837 were Widdy Henderson, James Curl, William Payne, Guian Brown, Turpin Thomas and Matt Ferrell, all deceased prior to 1881.

The following were still living in 1881: Judge Thomas A. Brown, from Tennessee in 1838; H. W. Baker in 1837 from Virginia; John Hickman from St. Louis in 1837; Levi J. Judah from Indiana in 1839, and Columbus H. Roundtree in 1837 from Kentucky. John, James and Cornelius McGuire who settled here about that time died before 1881.

Capt. William Fowler came in 1837 from Delaware and was the first Circuit and County Clerk of Buchanan Co., having been appointed in 1839. He died in St. Joseph in November, 1880, at age of 82 years.

Dr. Silas McDonald came from Kentucky in the spring of 1838. He later moved to St. Joseph.

Major Sandford Feland came to this township in 1839, purchased a claim east of the town of Wallace, and continued to live there. He stated that when he came to the township, the bark wigwams, which had just been vacated by the Sac Indians, were still standing on the banks of Bee Creek. He was a native of Kentucky and was an officer in the Kentucky militia.

Crawford Township, cont.

Guilford Moultrie, who built the first log Court House at Sparta, was a resident of Crawford Township, and died at his home some years before the civil war.

The oldest business center in the township was known as West Point. It was a single store, kept by Loel Pennick on a farm later owned by Milton Murphy. Mr. Pennick came with his family in 1838 and afterwards removed to St. Joseph.

BLOOMINGTON TOWNSHIP

Among the earliest settlers of what is now Bloomington Township, was Hiram Roberts. He came to the vicinity of DeKalb in 1836, a year before the county was opened for settlement. As soon as it was known that squatters had invaded the county, U. S. troops from Fort Leavenworth were sent to dispossess them. Perhaps, the only man who escaped the vigilance of the military, was Hiram Roberts, who happened to be overlooked, from the secluded location he then occupied. He died in DeKalb, Apr. 25, 1881, at age 79 years. Five days later, his wife, of nearly the same age, was buried. The inscriptions on their monument in the cemetery at DeKalb reads as follows:

"Hiram Roberts, born Dec. 6, 1801; died April 25, 1881, aged 79 years, 4 months and 19 days. Rachael Roberts, born March 18, 1802, died April 27, 1881, aged 79 years, 1 month 9 days."

Isom Gardner, Amos Horn (a native of Lafayette Co., Mo.), John Underwood, Holland Jones, Thomas Hickman, William Hickman, William Ballow, Matt Geer, Hardin Hamilton, Mrs. Sally Davis, F. D. Davis, her son, Thomas Hill, Major F. D. Bowen (died in 1867), Stephen Field, who built the first mill in the township, James Hamilton, and Isaac Van Hoosier (who died in 1879) were all here in 1837.

The Gartens (Zachariah, who died in 1852) with his sons Uriah and John, have lived in Nodaway County since 1842. William, who lived just south of DeKalb, and Stephen came to Bloomington Twp. in 1839. Lewis Garten also came in 1839, but later went to California.

In 1841, Major Francis Drake Bowen, a native of Fairfax Co., Virginia, settled near the town of DeKalb. He bought from James Linville, a claim which he afterwards entered, about 2 miles from DeKalb. He then went to Kentucky where he taught a school five months, returning the same year to this township and resided here until his death on Nov. 13, 1867, aged 73 years. His estate included some of the finest farms in the county and it descended to his two nephews, Peter and William A. Bowen. Major Bowen was at one time an officer in the War of 1812. He never married. John Bowen, a brother, came from Virginia in 1832, with his wife and three sons, William A., Lovell, who was

killed in the battle of Pea Ridge fighting for the Southern cause, and Peter O. Bowen. John Bowen died July 5, 1862, age 71, and his wife in July 1879. Francis Drake Davis, a cousin of Major F. D. Bowen, located here in 1837 from Fairfax Co., Va. His mother, Mrs. Sally Davis came out soon after with another son, John, who died on his way to California in 1849. About 12 years later Thomas Davis, a third son, came to Bloomington Township. Mrs. Davis died at the residence of her son, F. F. D. Davis, at the advanced age of 100 years, having been born in Virginia in Dec. 1773. Thomas Davis died in 1880, age 80. It was said that the Bowens were lineal descendants of Sir Francis Drake. Mrs. Davis had two daughters, Mrs. Bryant and Mrs. Peoples; the former died in Bloomington Twp., and the latter in Lexington, Mo.

Michael Gabbard, who settled here in 1838, died in Dec. 1878, age 79 years. Benjamin Yocum, a farmer from Kentucky, settled in the township in 1839. Governor Robert M. Stewart immigrated to Bloomington Twp. in 1839 from New York. In 1845 he moved to St. Joseph. James Ellison was also an early settler, as was also Judge Curl, who at one time represented Carroll Co., Mo. in the Legislature.

William Moore, a son-in-law of James Ellison, came in 1839 and was Deputy Sheriff and Constable for several years. He died in 1847.

Captain William Moore and David Brown were both early settlers. William Clasby came from Calloway Co., Mo. in 1838; Benjamin Sampson and his brother, John, came in 1838. Abraham and Wm. Womack settled here in 1838. Rice McCubin was an early settler, and was living in Kansas in 1881. William Fountaine died before the war and his widow became the wife of P. R. King. Holland Jones and Joel Hedgpeth opened a small store in 1837. John Dairs, a native of Virginia, was the first man to distill whisky in the township, prior to 1843. He died on his way to California. Judge Cornelius Roberts, a brother of Hiram Roberts, settled in the township in 1837, and Judge J. P. Pettigrew came from Mercer Co., Pennsylvania, in 1839. P. R. King came from Montgomery Co., Mo. in 1848.

CENTRE TOWNSHIP

Among the first settlers of Centre Township was Richard Hill, who in the fall of 1837, settled in the immediate vicinity of the subsequent town of Sparta. Robert Duncan, William Hunter, and Andrew J. Hunter settled east of Sparta in 1839, and John Richey also came the same year. About the same time came James Donovan of Augusta, Kentucky, John Hill, Samuel Hill and Joseph Hill.

Captain William Fowler, General B. F. Loan, Gov. W. P. Hall, General James B. Gardenhire, Judge Henry M. Vories, Judge Wm. B. Almond and General J. M. Bassett located in Sparta between

1840 and 1845 and moved to St. Joseph after the removal of the county seat to that place in 1846.

Among the early settlers in this township were: Jesse Reames, Zachariah Waller, Elijah W. Smith, Lucas Dawson, John Croy, John Martin, Thomas Moore. William Farris came from Indiana in 1840; George Raney from Indiana. Other settlers were H. G. Gordan, James Woodward and Robert Donnell, Evan Jordan, Ransom Ridge, Martin Hirsch, and Joseph Mathers and his brother-in-law, Oman Miller. Samuel McCauley settled here in 1840, coming from Lancaster, Pennsylvania. William C. Connett, father of William C., Squire S., and Horace F. Connett, settled here in 1839, from Lexington, Kentucky.

John Copeland settled in 1840. He died in 1873. He was born in North Caroline in 1768, moved to Tennessee in 1829 and in 1840 to this place.

RUSH TOWNSHIP

Among the early settlers of Rush Township still living in 1881 was William Allison who came in 1837. John H. Allison also came in 1837; James Canter, in 1837; John Seips and Eli Seips in 1839, and Mitchell Owen in 1839, and also, John Utt. Henry Hays and Sylvester Hays, Morris Baker and James Carpenter (who sold his farm to Burgess Elliott about 1841) came in 1839. The first settler on the quarter section including the town site of Rushville, was John Flannery, who came in 1839. He afterwards sold to Perman Hudson and James Leachman.

AGENCY TOWNSHIP

About the first settlements in what was known as Agency Township were John Gilmore and his brother, Robert, who located here in 1837. They were natives of East Tennessee and first settled in Clay County, Mo. Robert Gilmore was the father of James J. Gilmore and brother of James Gilmore, who lived in the Platte county country as blacksmith for the Iowa and Sac Indians, long before it was settled by the whites. James Gilmore died in Oregon.

James J. Reynolds came from Clay Co., Mo. in 1838; Samuel Poteete came from Tennessee, originally, and settled here in 1837. William McDowell, who died in 1874, came from Clay Co. in 1837. Jacob Reese, a native of North Carolina, reached the county about 1838. Benjamin Moore, from Virginia, and Littleberry Estes settled on Pigeon Creek. John McGauhey came from Indiana in 1839, and Bright Martin about the same time. John Lamb came in 1839 and died en route to California. Richard Fulton was one of the early settlers.

MARION TOWNSHIP

Marion Township, from the fact that the territory occupied the northeastern part of the county, was not so rapidly or thickly

settled as the southern portion. The first settlers generally occupied that portion of the county lying contiguous to the Clinton County line.

Calvin James was one of the earliest settlers of Marion Township. He came from one of the older counties of Missouri in 1837. Benjamin Cornelius, from Clay, came in 1837. Peter Boyer, the father of Jacob and Henry Boyer, was from Pennsylvania. James Blakely came from Kentucky in 1838; Thomas McGowan also came in 1838. Jesse Clark, originally from Tennessee, but came from Clay County to Buchanan in 1838, and Barnes Clark came at the same time. The Markers and Caleb Hasenmeyer came from Ohio. John Ledgerwood came from Clay County in 1839 and Nicholas Roberts and James Roberts in 1838 from Clay Co. James McCorkle, also came from Clay County in 1838. Joseph Kessler was one of the first German settlers.

Among others who came at an early day: John Wunderlich, Wolfgang Beck, John Slaybaugh from Pennsylvania; David Davis, from Ohio; Dr. John Minor, from Kentucky; John Davis, brother of David, from Ohio; Isaac Gibson, from Missouri; Isaac Voochies; William P. Shortridge, from Kentucky; Augustus Wiley and James Wiley.

WAYNE TOWNSHIP

Peter Price, one of the earliest settlers, came in 1837, and located where Thomas Leisure later lived. James M. Hawley and Stephen Hawley, from Indiana, settled in 1839. Isaac Lower, from Tennessee, came in 1837. William Jones settled where his sons, Levi and Frank later lived.

William Dunning settled in the township in 1839. He was born in Guilford, N. C., in 1794; served in the war of 1812; married in Tennessee in 1821, and moved to Bloomington, Indiana, where he filled several important offices. He died in 1879.

Daniel Devorss, a native of Ohio, came to Missouri from Indiana very early, and Henson Devorss came in 1846, but in 1843 had lived in Washington Township.

LAKE TOWNSHIP

Lake is the smallest township in the county. The early settlers were mostly from Bartholomew Co., Ind. William McHammer came in 1841, and Henry Sibert, father-in-law of Isaac L. Peck, came in the fall of the same year. Nathaniel Wilson, father of John, came in 1841, as did William McGalliard, James McKinney, John McGalliard, James McGalliard, Thomas McGalliard, James Wilson, and Eli Gabbert, all from Bartholomew Co., Ind.

TREMONT TOWNSHIP

One of the first settlers was Ishmael Davis from Kentucky, but a native of Maryland, who came in 1837. His son, R. T. Davis,

born here in April, 1837, is said to have been the first white child born in the county. Ambrose D. McDaniel came from Kentucky in 1837. He was killed at his home in this township during the war of the rebellion. George Jeffers, a native of Tennessee, came from Clay Co. in 1838 and pre-empted the place later owned by his son, James M. Jeffers.

James Gibson settled in 1839 and Harold Miller came with him. He was from Virginia. Robert Irwin was born in Tennessee, but came here from Clay Co. in 1838. He emigrated to Oregon and died there in 1876.

Stephen Bedford was from Kentucky, but had lived in Clinton Co., Mo., before coming to Buchanan. Daniel McCreary, from Tennessee, settled in 1838, as did Joab Schultz, also from Tennessee. Henry Jones came from Clay Co. He was murdered in 1848 by a man named Gibson. Creed Herring, a native of Shelby Co., Ky., settled in 1843. Edward M. Trotter and M. D. Finch came about that time. Wilson P. Mudgett and P. P. Mudgett came in 1839.

WASHINGTON TOWNSHIP

Joseph Robidoux was the first white man to locate within the limits of what is now known as Washington Township. His name is inseparably associated with the history of St. Joseph, from its foundation in 1868, date of his death.

Among the early settlers of this township were John H. Whitehead and William Whitehead, brothers, originally from Virginia, but who came here from Clay Co., Mo. James H. Whitehead was also an early settler. Henry W. Hanson came from Kentucky in 1837. James Cochran and Frederick Waymire were among the early ones. William Pough, a Kentuckian, came from Clinton Co. in 1837, and Claiborne F. Palmer from Ray County in 1838.

A. C. Hyde came from Kentucky in 1840. Thomas, John and Elisha Sollers, James Highly, Stephen Parker and Isaac and Michael Miller were all early settlers. James G. Karnes came from Monroe Co., W. Va., in 1839. Alexander Fudge, originally from Covington, Va., came from Clay Co. in 1839 and located on the place where he died in January 1875.

Sabert Sollers settled here in the fall of 1839 and Leroy Kaufman in the same year. Benjamin Williams and Jacob Groshon were early settlers. Logan James and Edward Maxwell made settlements in the township in 1837. Other very early ones were Isaac Waymire, John H. Cox, the McCorkles, David Ewing, William Sally, Joseph Davis, George Coughern, Michael Ballew, F. B. Kercheval, Michael Rodgers, and John C. Mansfield.

Simeon Kemper came out in 1839 from Kentucky, but did not bring his family until 1840. Frederick W. Smith came in 1838. Dr. Daniel G. Keedy was the second physician to locate in the county. Gen. Bela M. Hughes, later of Denver, Colo., settled here.

Washington Township, cont.

Other early settlers of this township were Robert I. Boyd, William T. Harris, Joseph Gladden, John R. Carter, Samuel C. Hall, Richard Gilmore, John B. Hundley, William P. Richardson, Isadore Pouline. The township contains a considerable German settlement. Nicholas Ozenberger was the first German settler. He came from Wayne Co., Ohio, in 1847.
