The information contained in this book was copied from the original Will Books A & B kept in the office of the Probate Judge in Carthage, Jasper County, Missouri.

We have included in this manuscript : the testator or testatrix, the wife or wives, the children, grandchildren, executor, and in some cases sons-in-law, daughters-in-law, nieces, nephews, brothers, and sisters, occasionally mothers and fathers. In a few cases where other heirs were mentioned, these were not given.

We have tried to copy these names just as they appeared. No change in the spelling of any name was intentionally made. Many of these names were spelled differently than they are today. Newcomers and especially those that spoke a different language had various ways of spelling their names. Clerks occasionally erred in interpreting the handwriting. Therefore you should check every spelling of the surname which you are hunting. If in doubt as to the name, or you desire more information, a photo-copy of the original will can be obtained from Probate Judges' office. At this writing, they are a dollar a copy.
