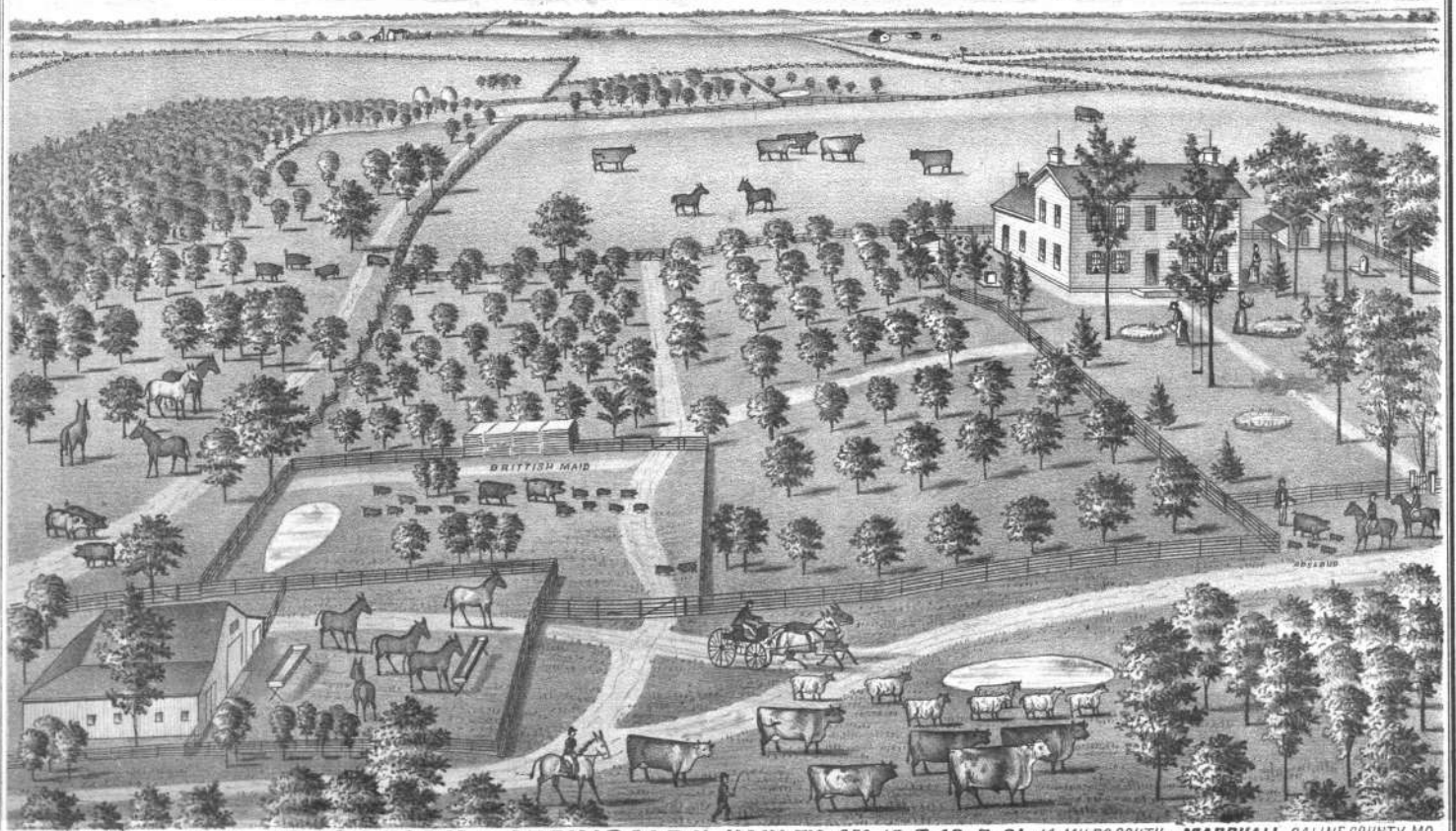

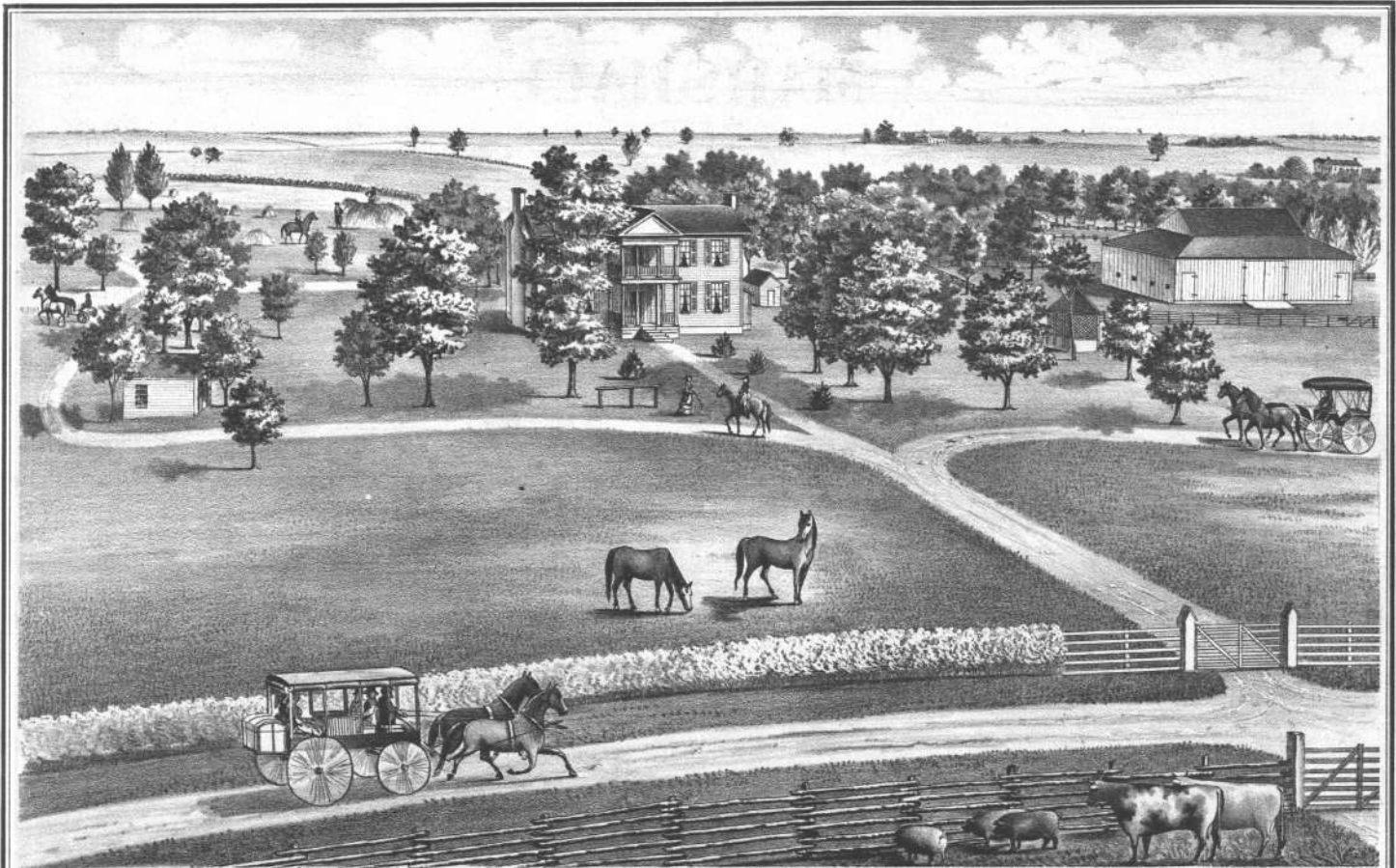

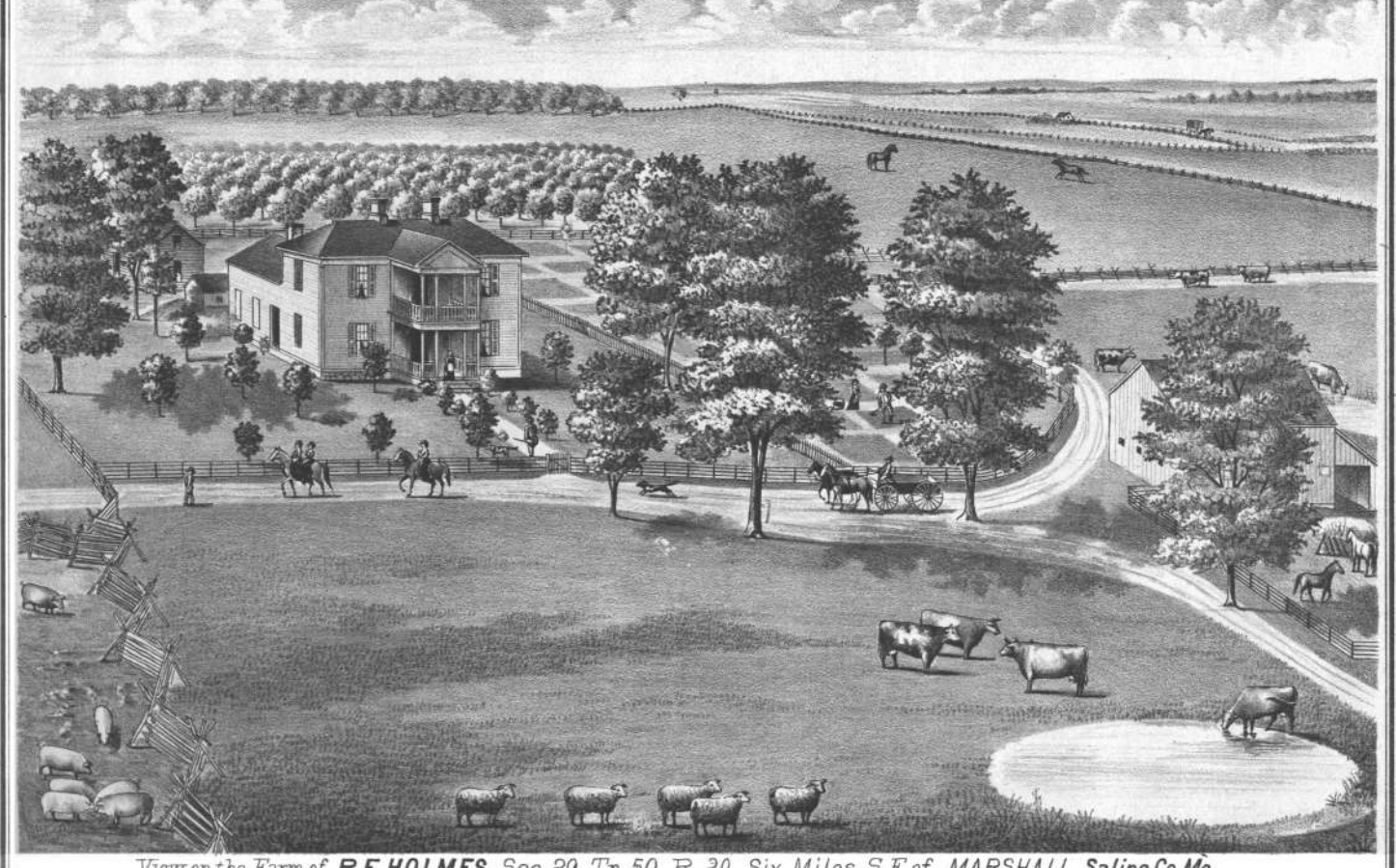

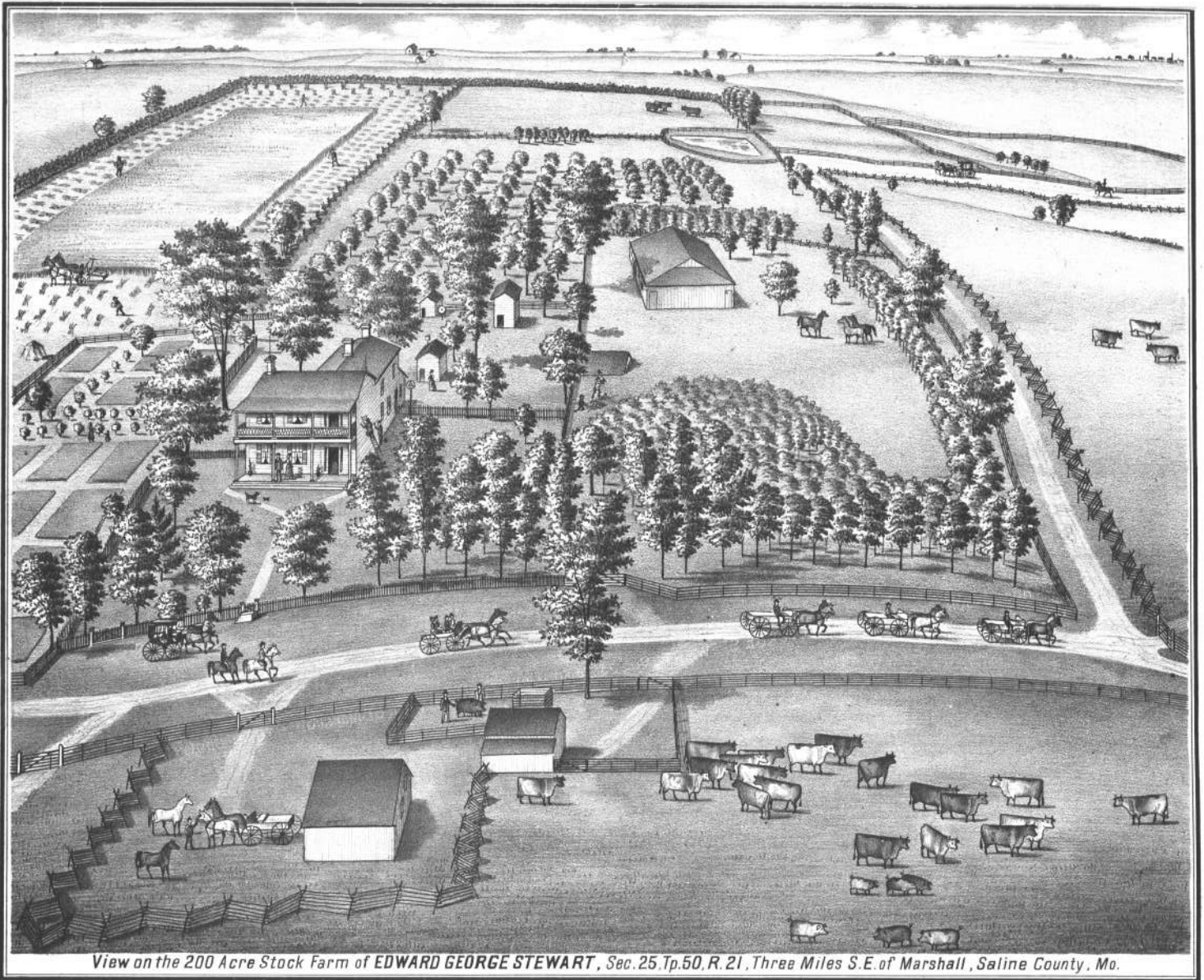

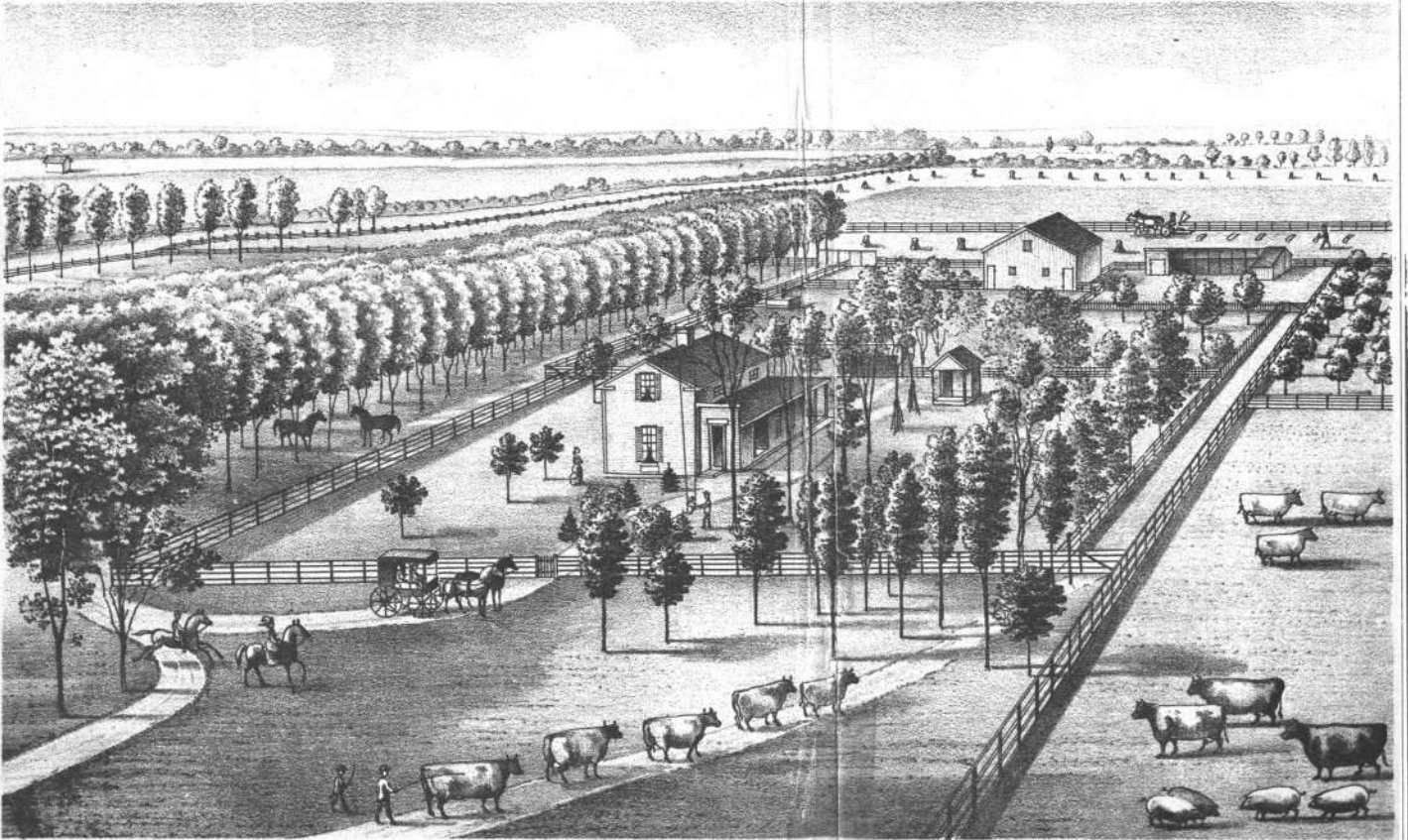

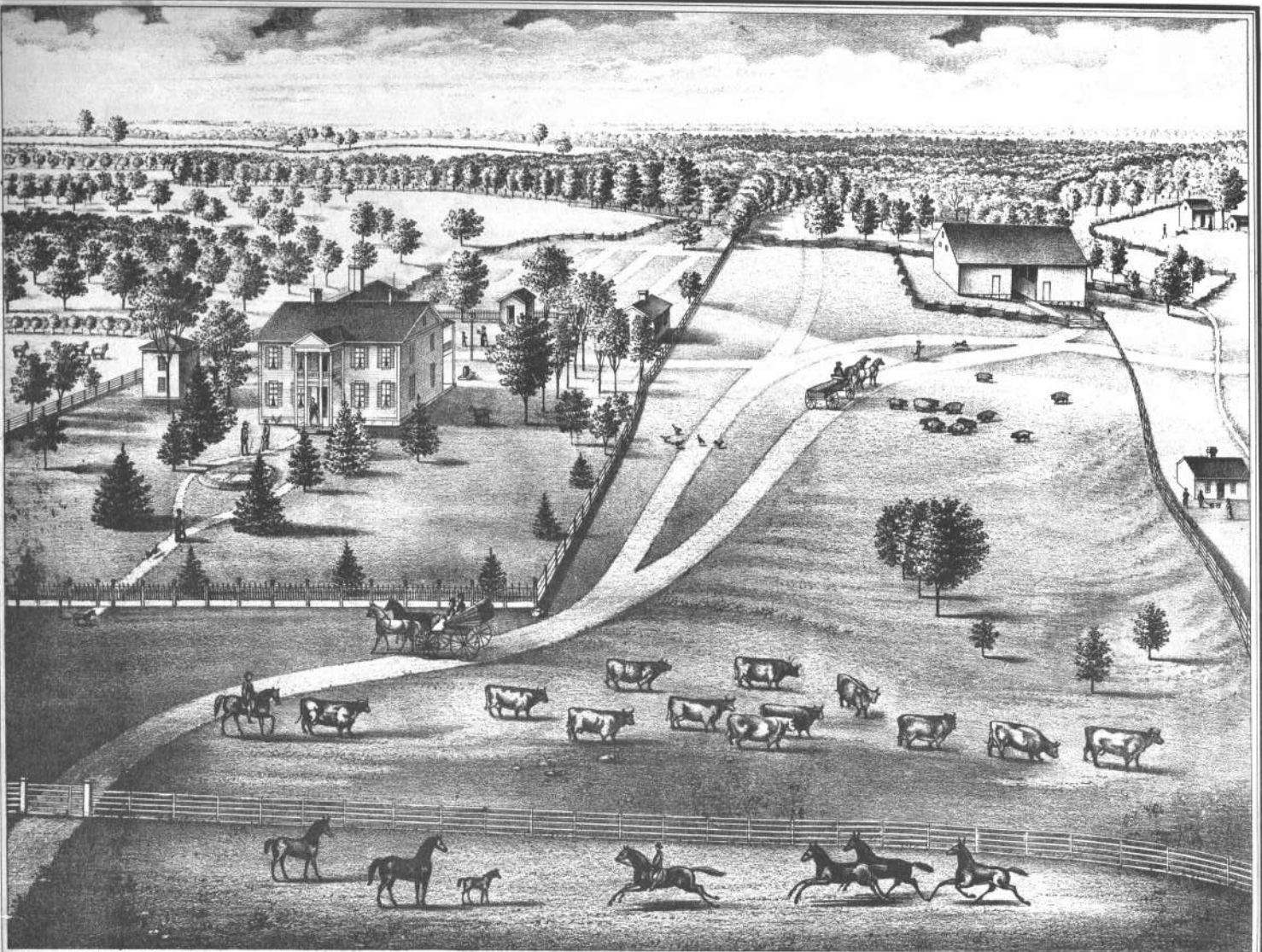

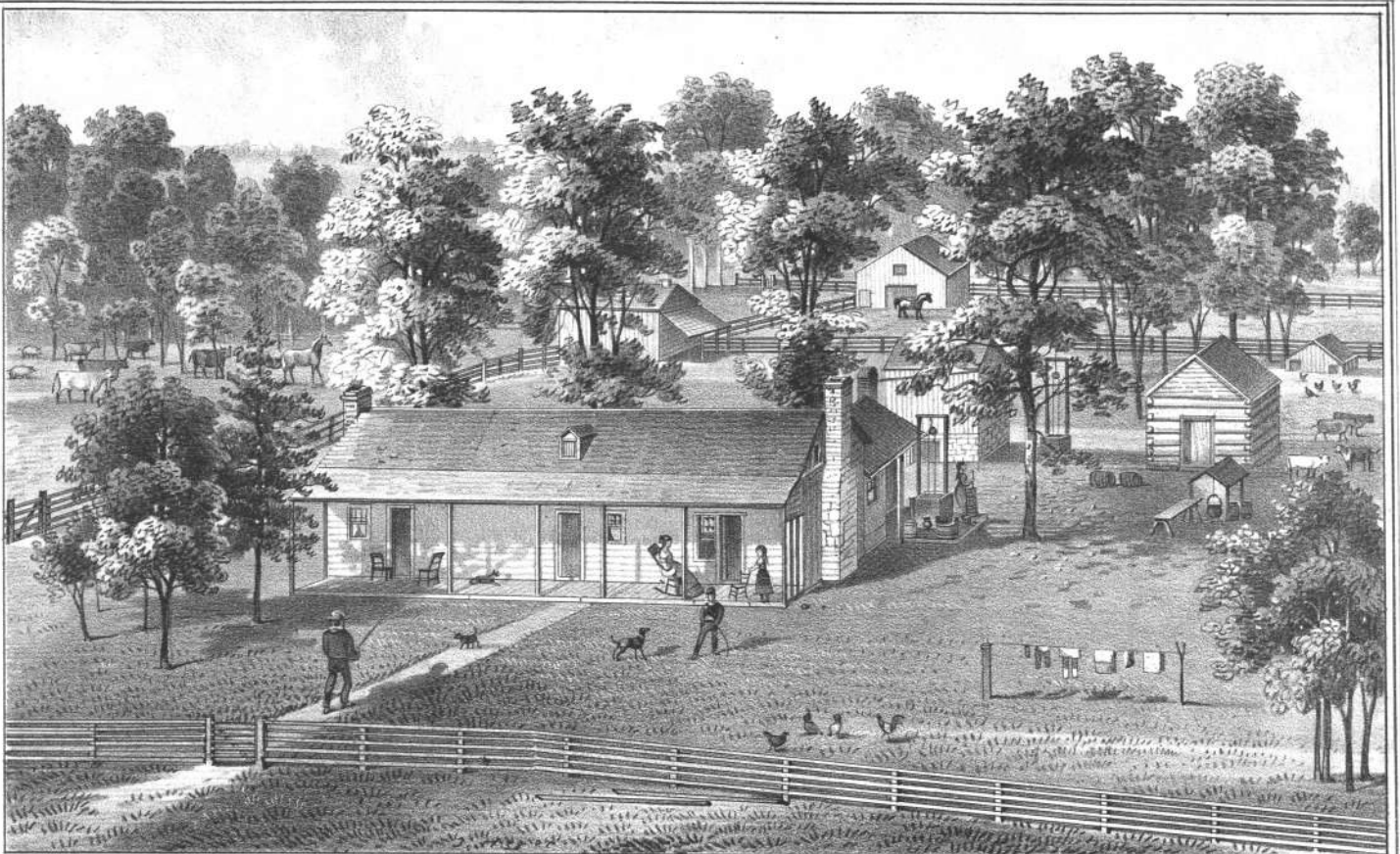

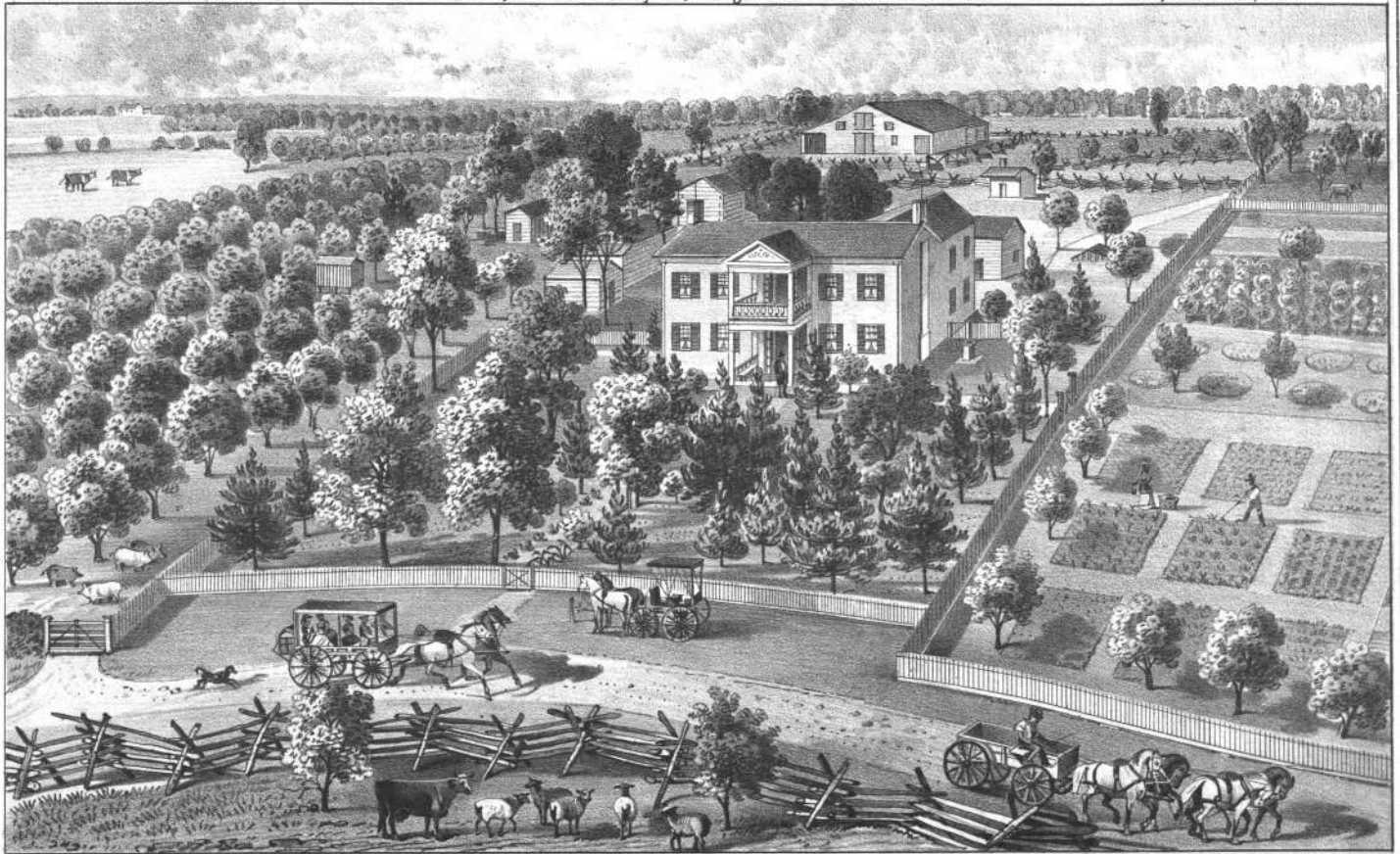

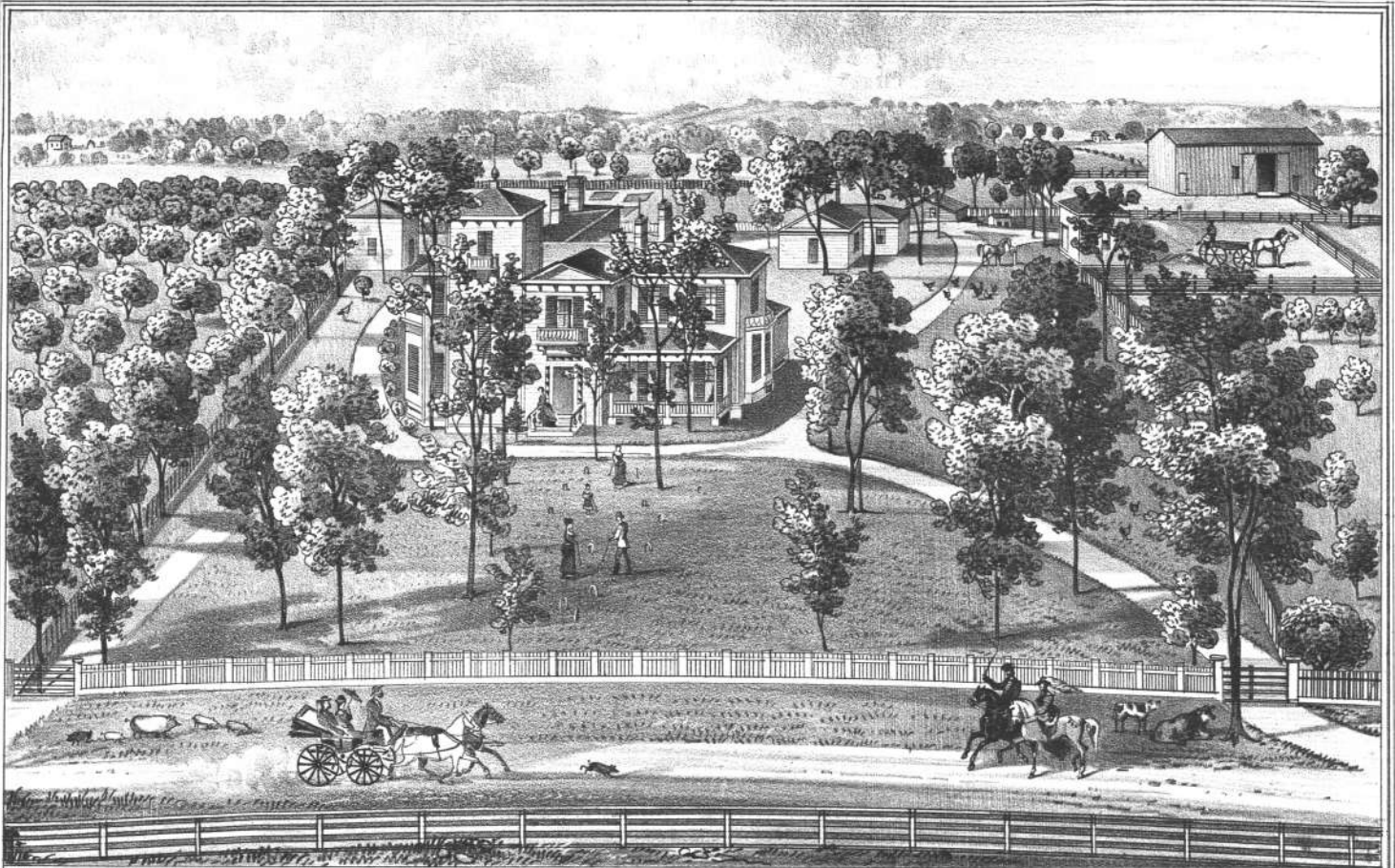

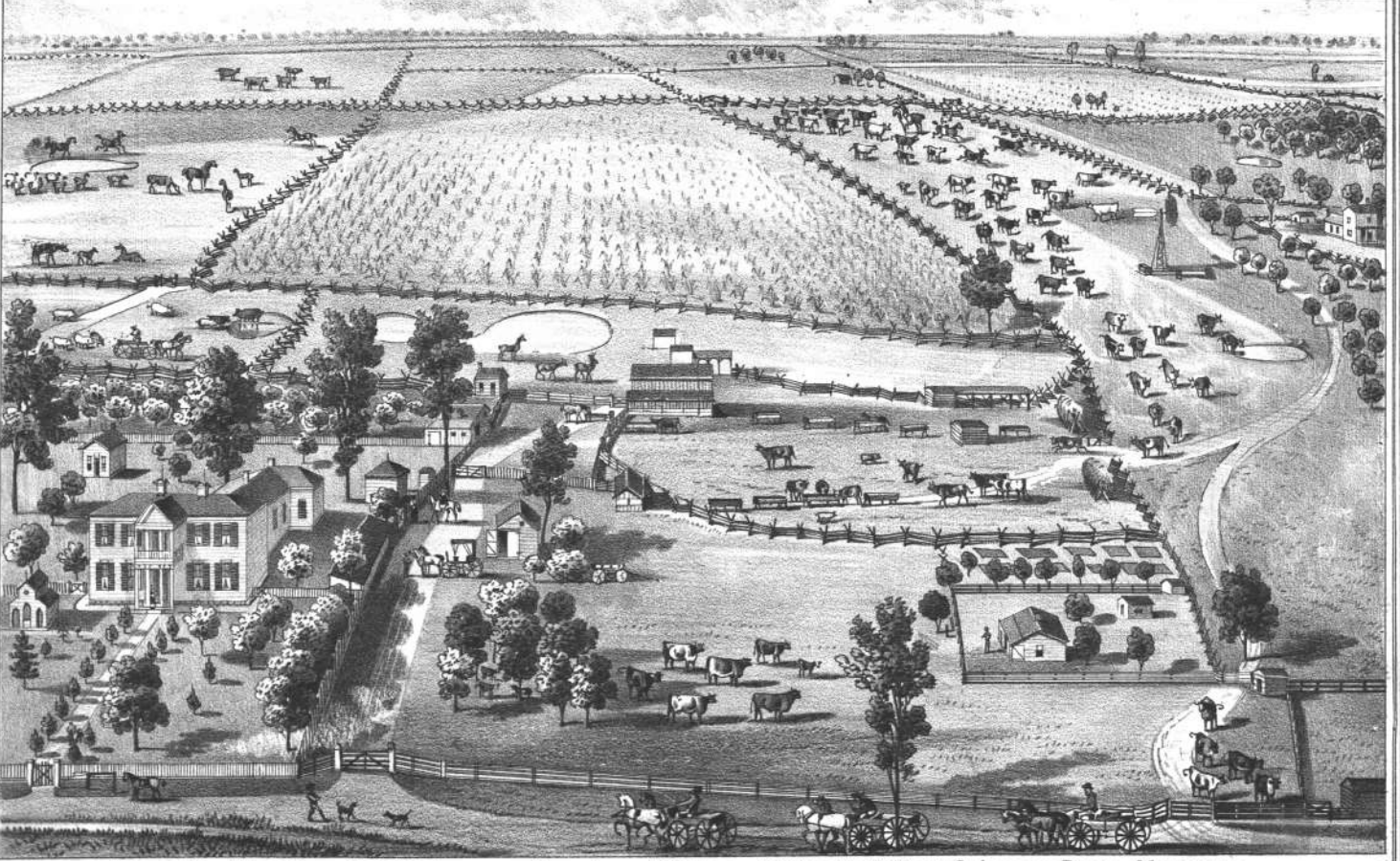

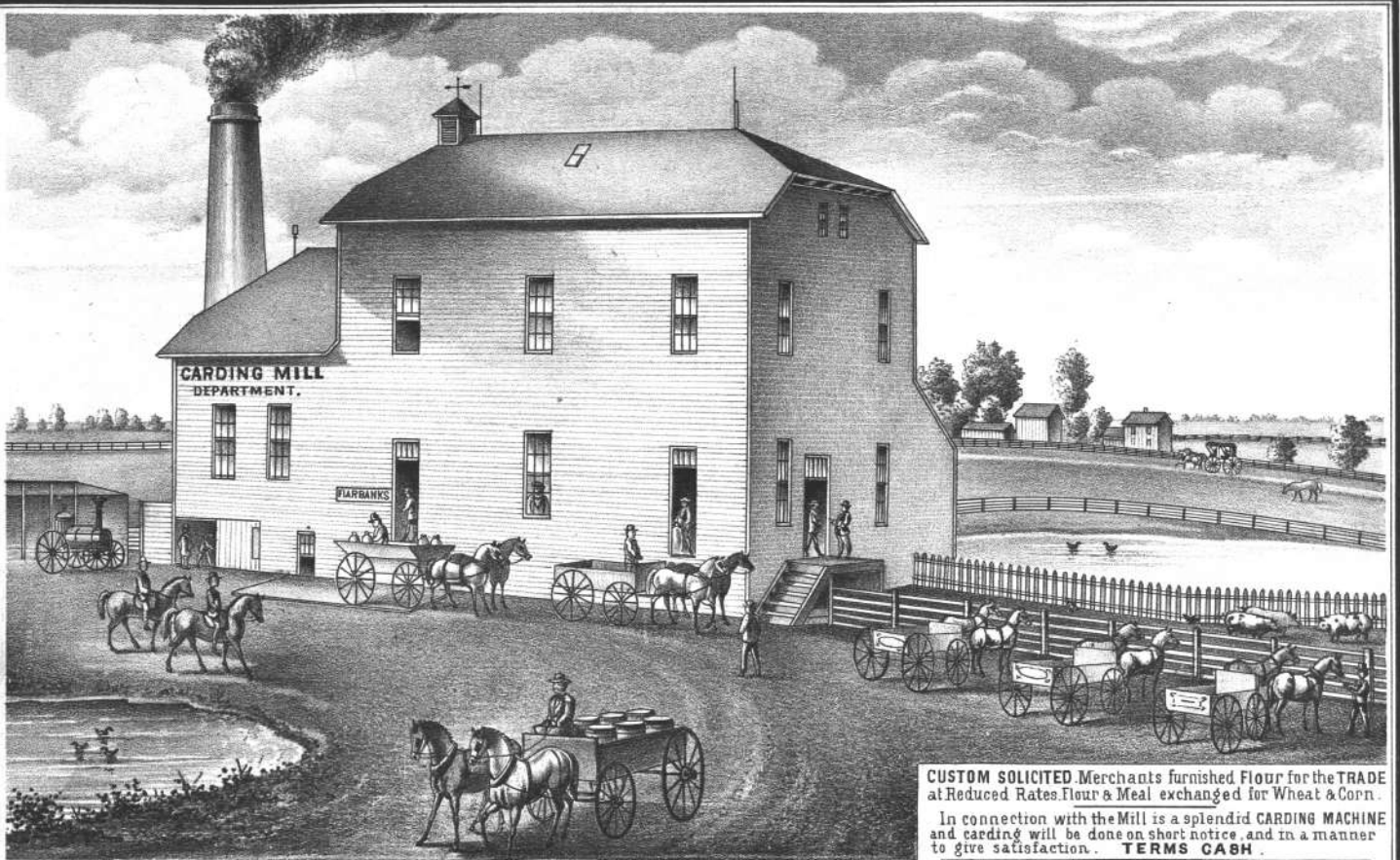

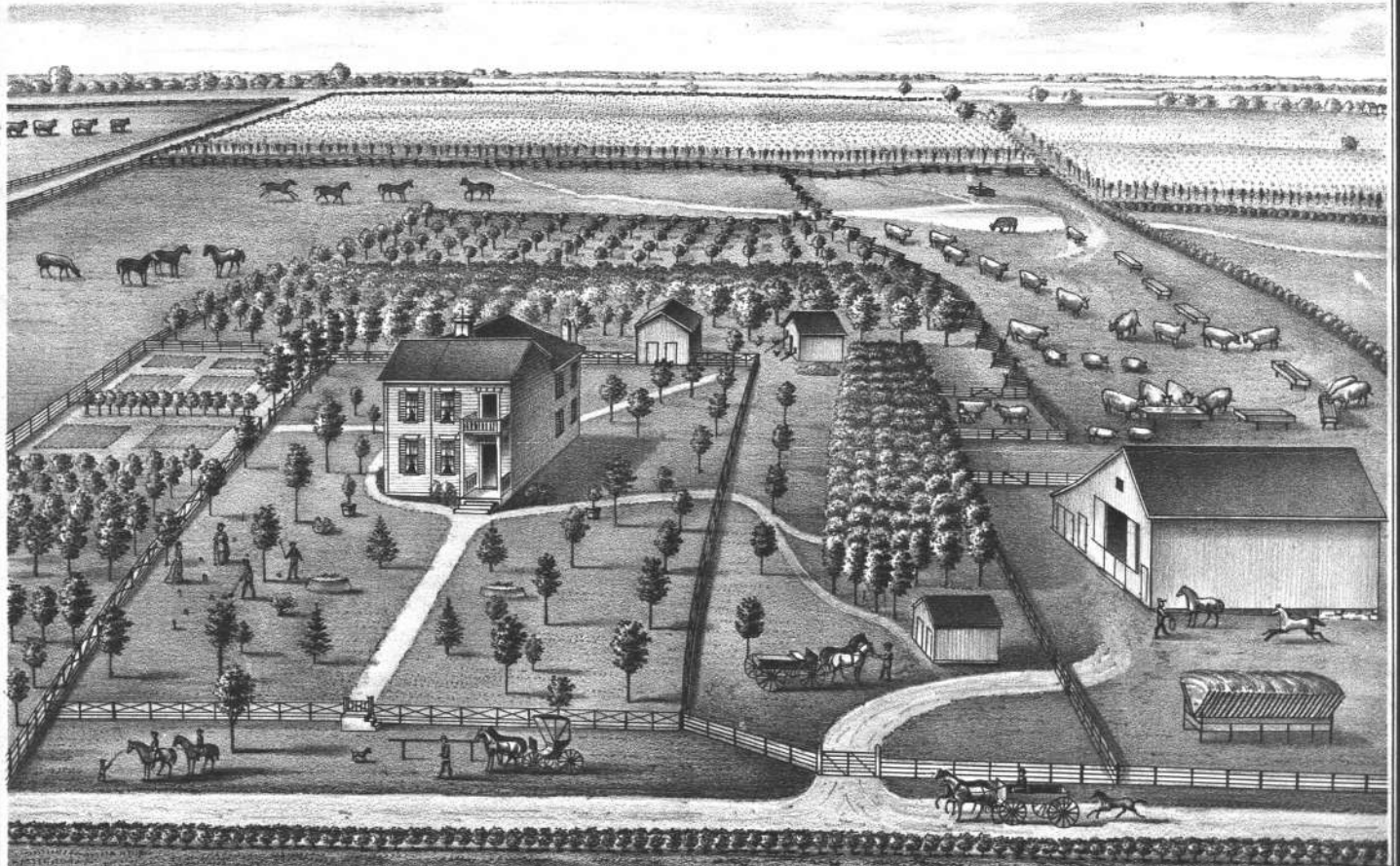

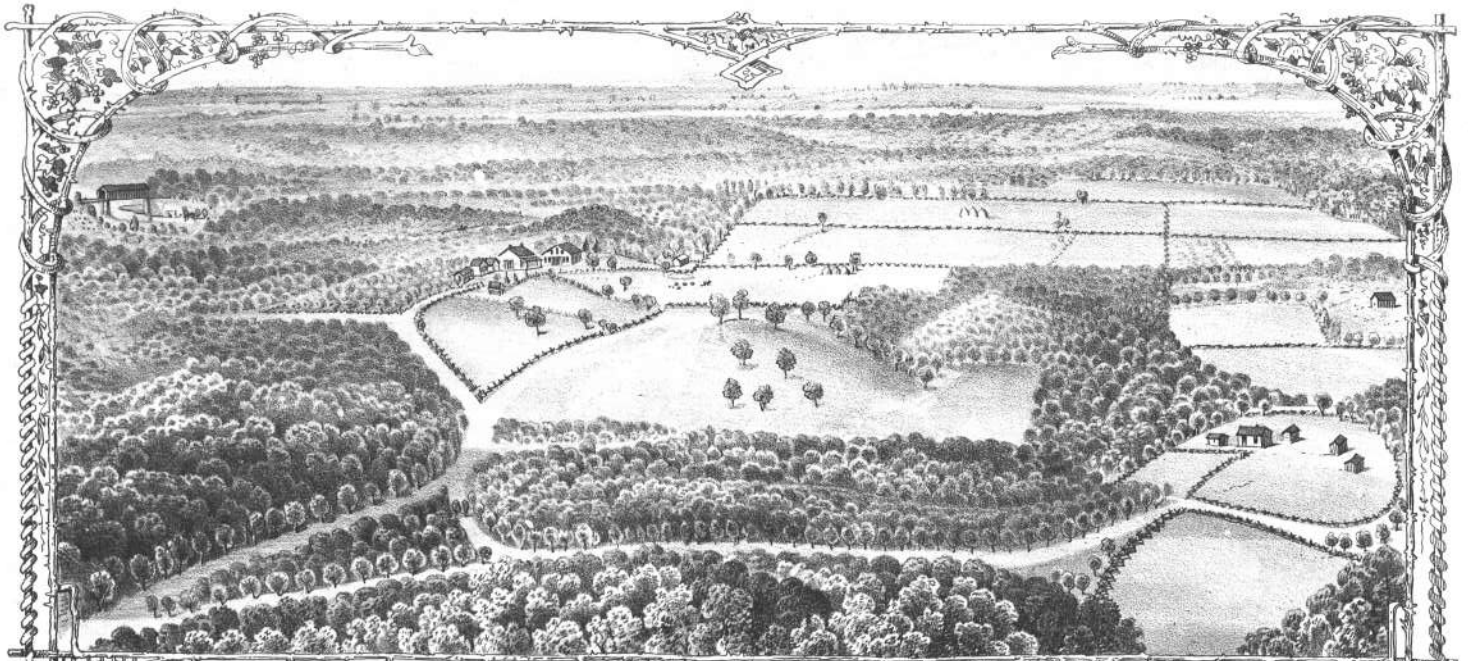

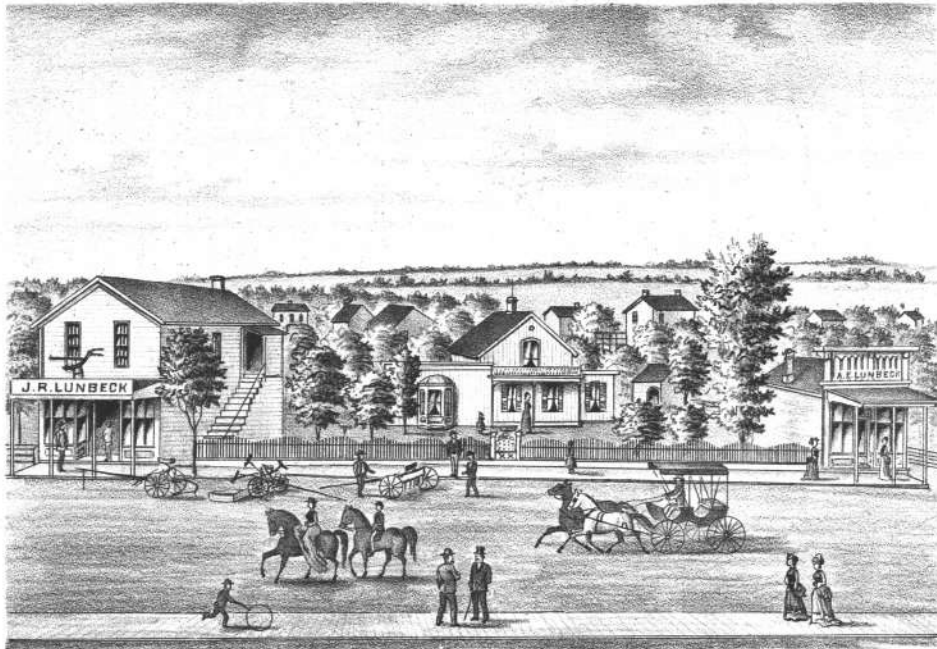


LANDSCAPE View of the FARM from the SOUTH.

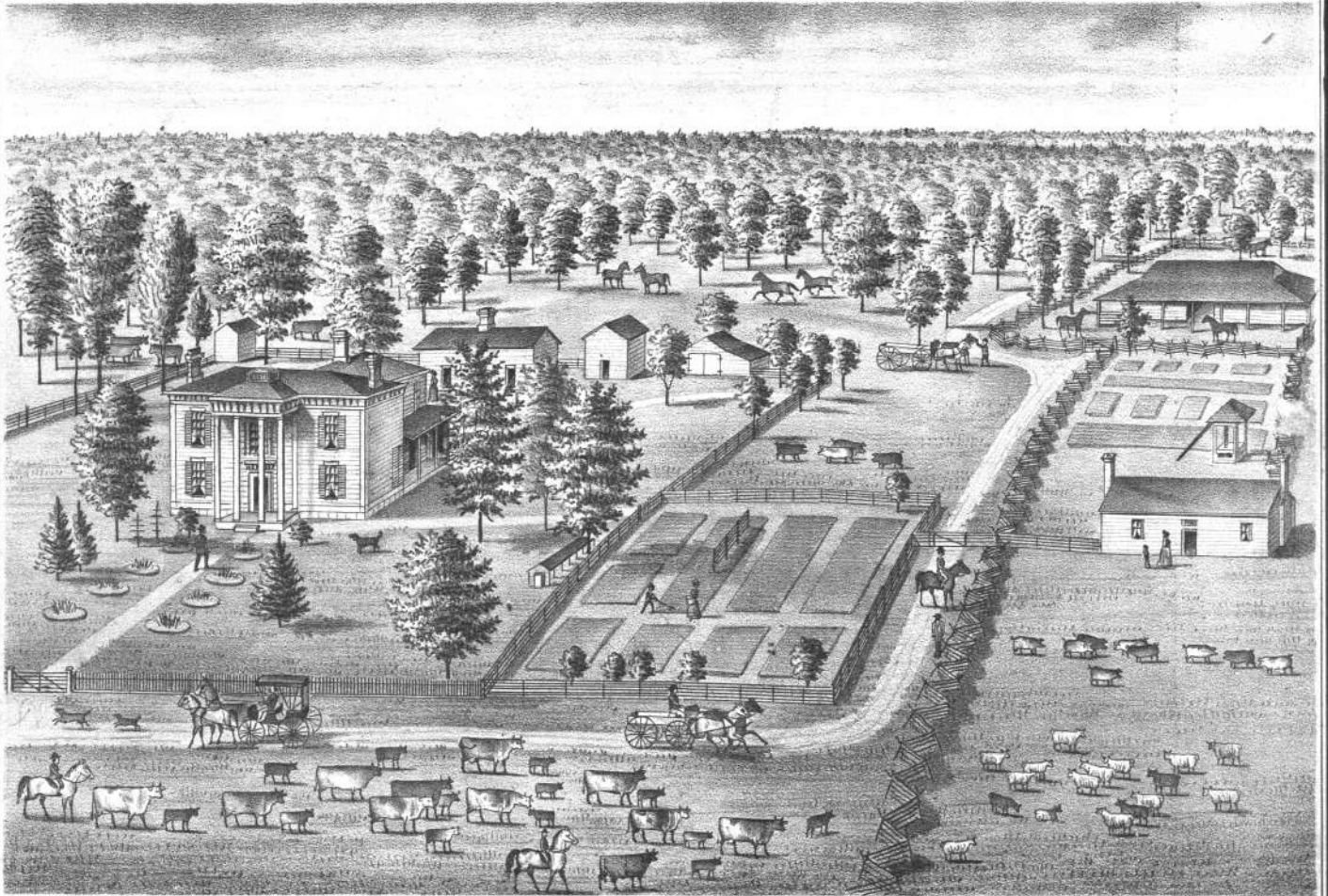

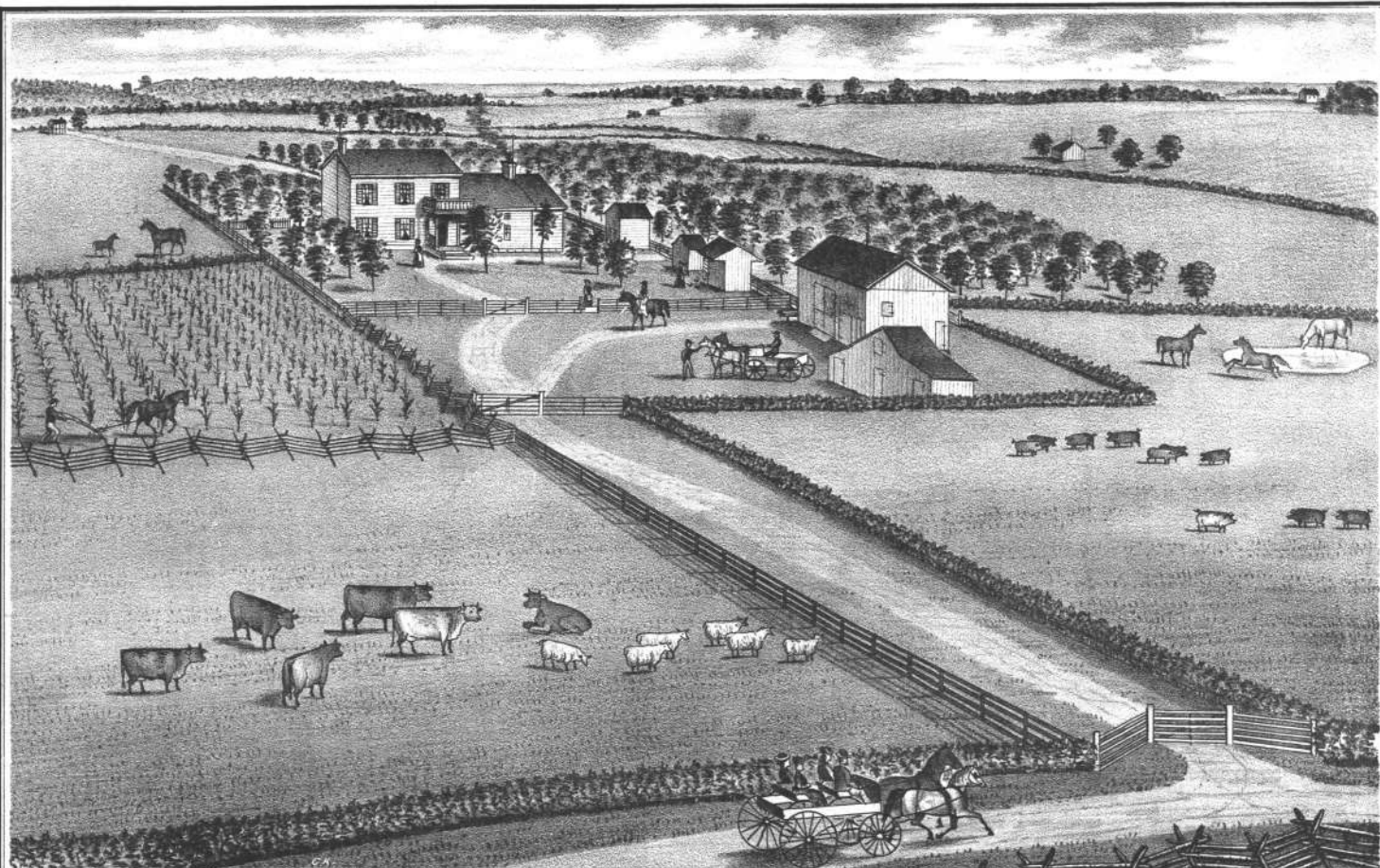

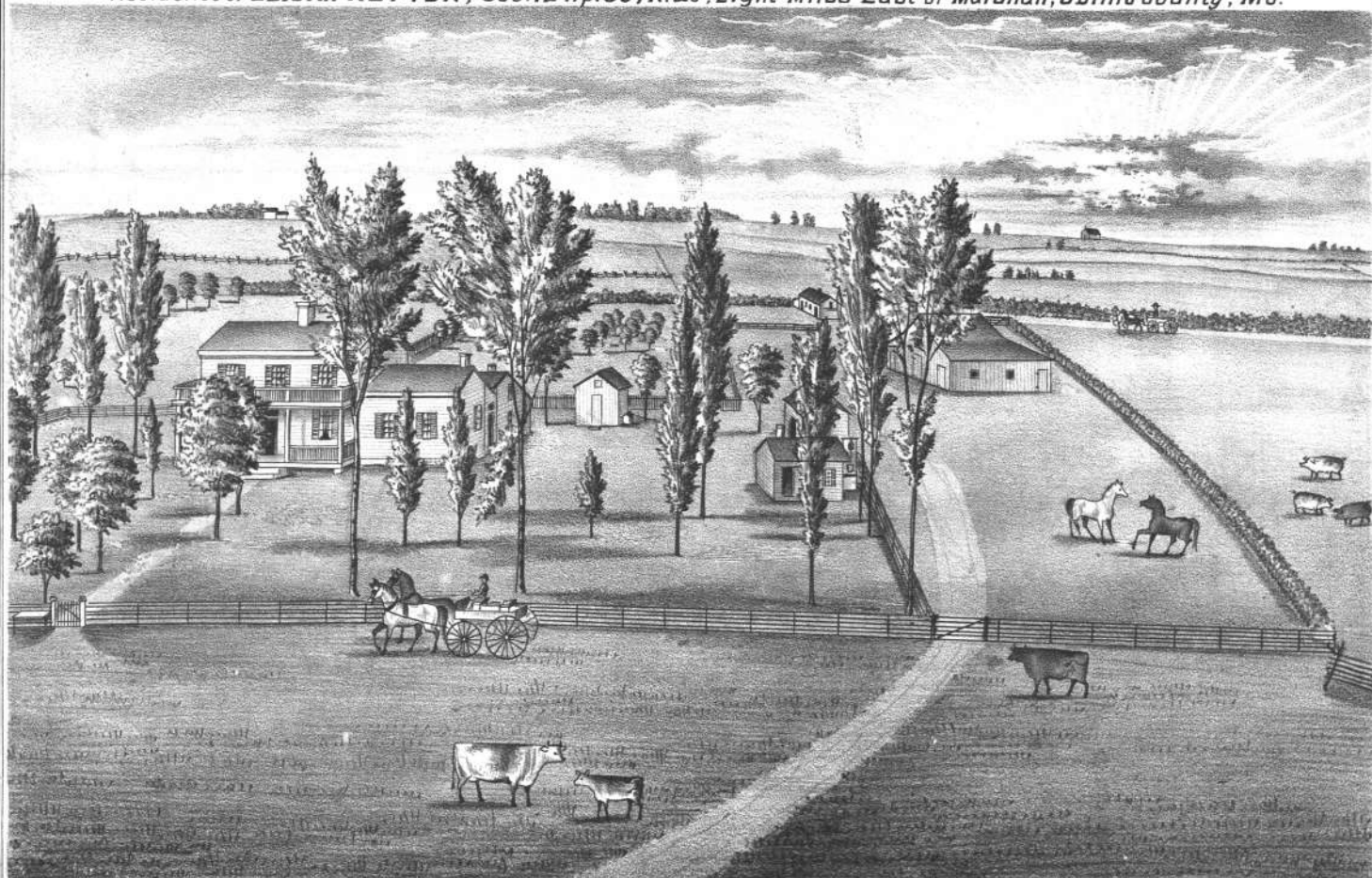
VIEW OF "OAK GROVE" RESIDENCE AND FARM PREMISES OF GEORGE A. MURRELL,
SEC. II SALT FORK TOWNSHIP, NINE MILES S. E. OF MARSHALL, SALINE COUNTY, MO.



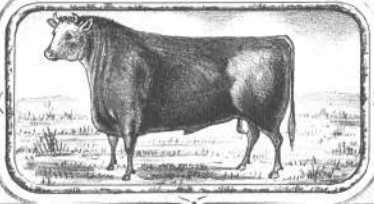
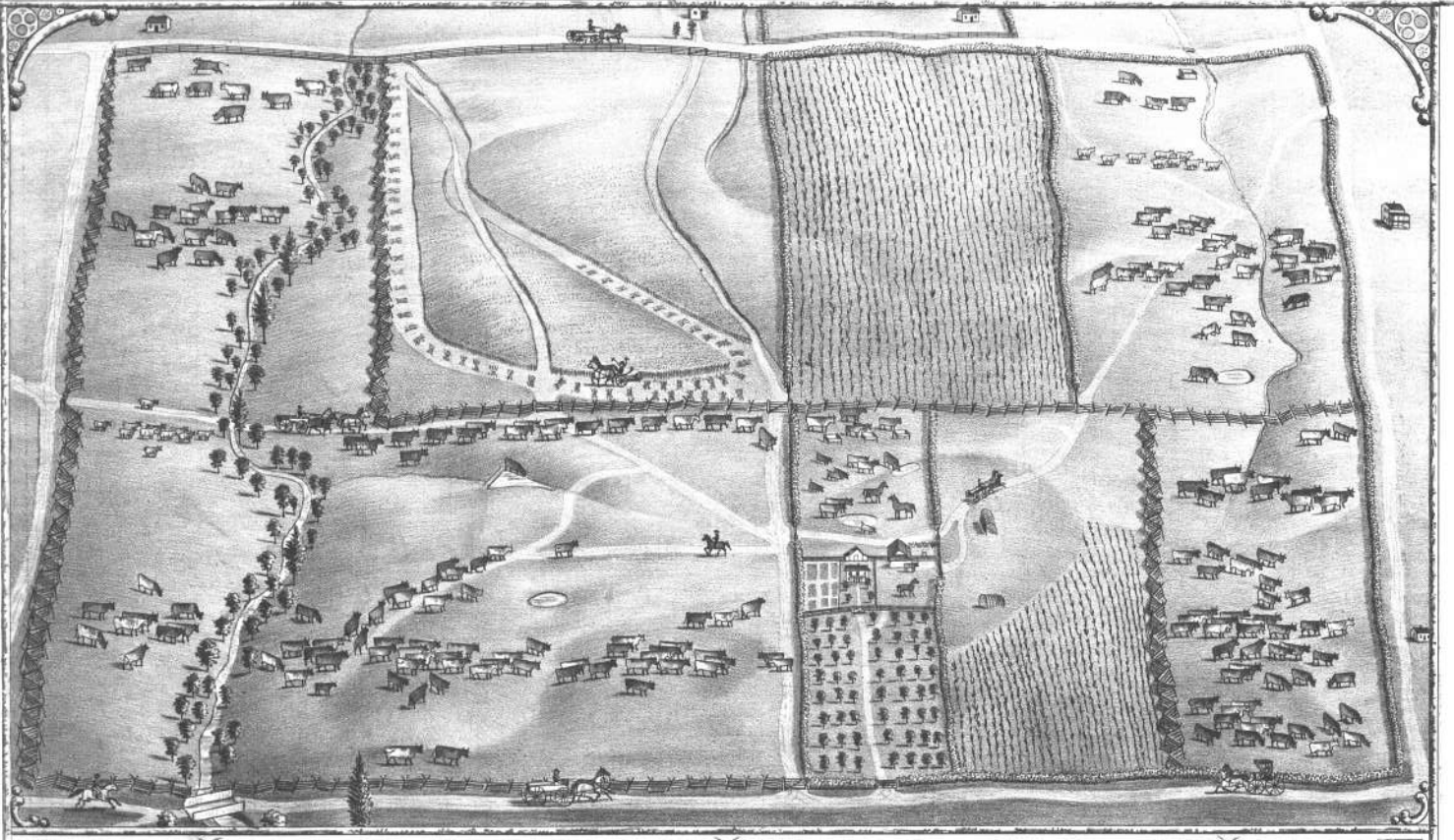

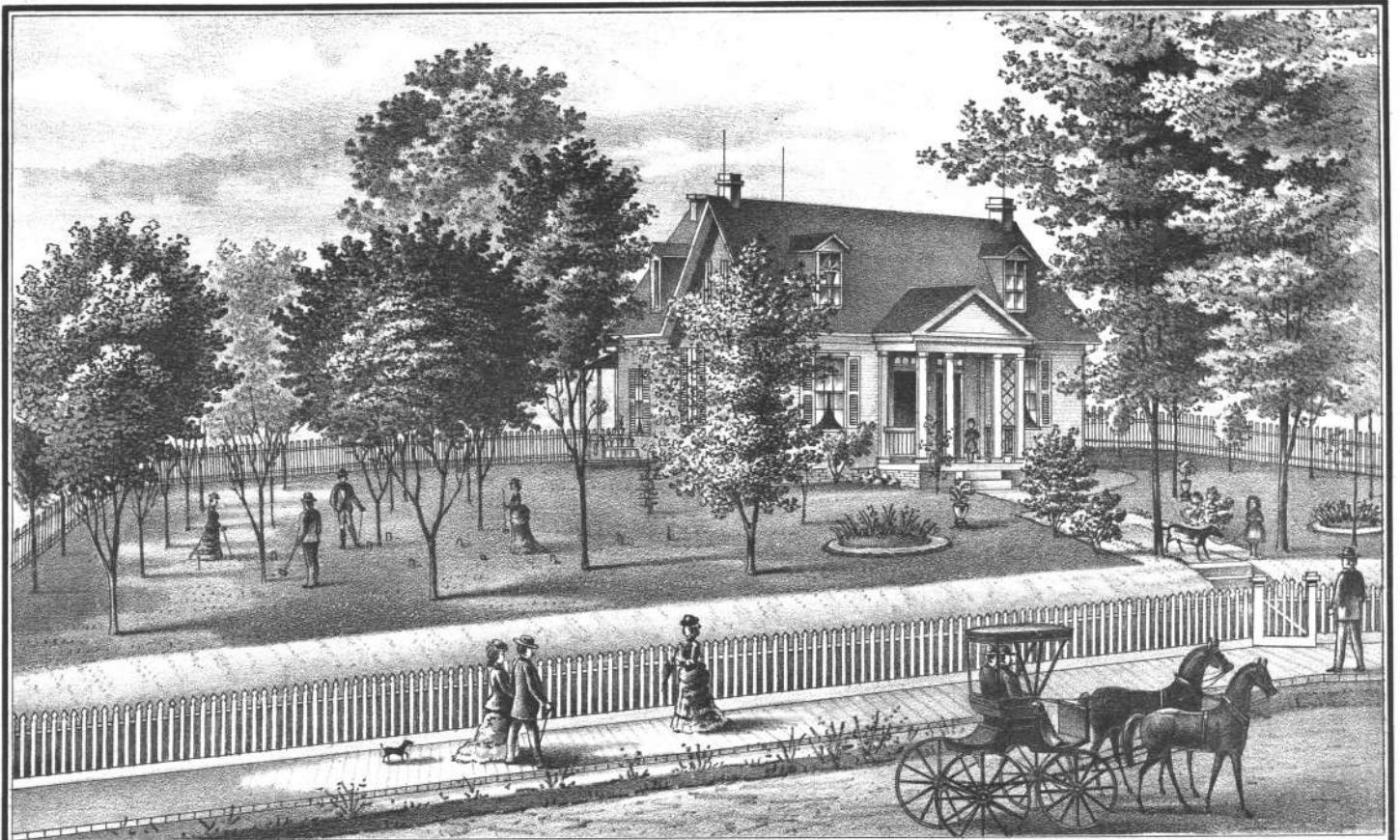
Residence of **ELIJAH KEYTON**, Sec. 12, Tp. 50, R. 20, Eight Miles East of Marshall, Saline County, Mo.



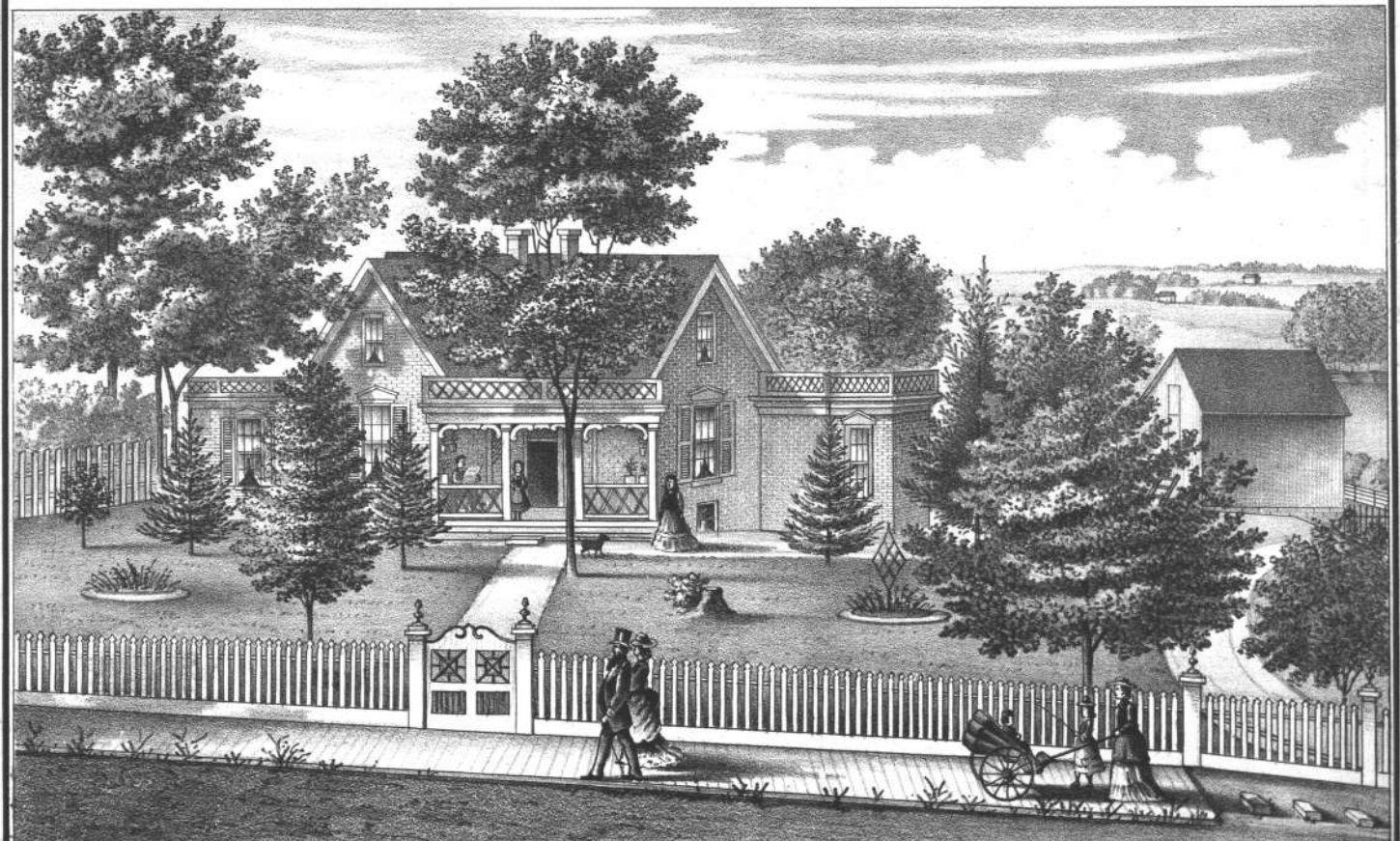

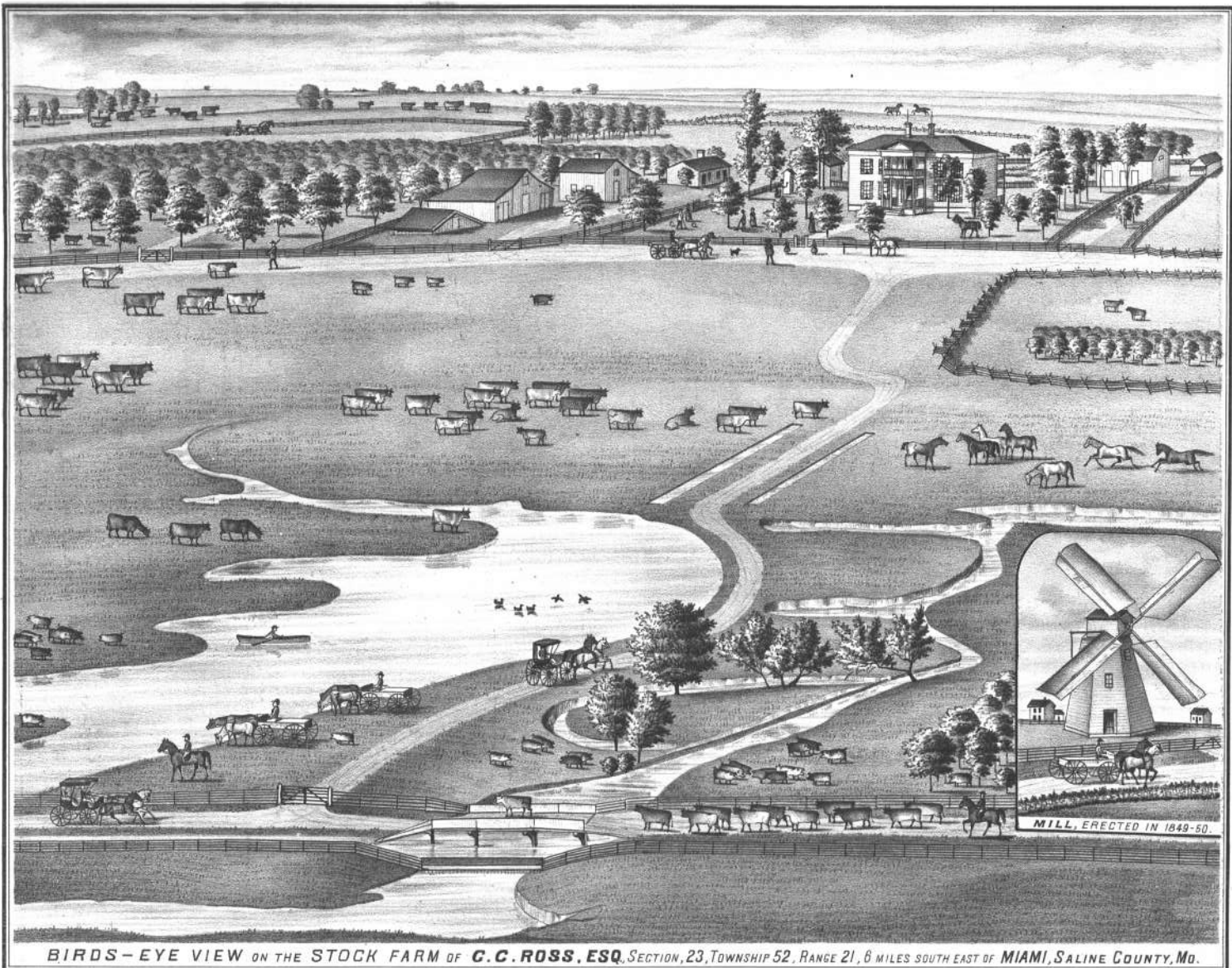

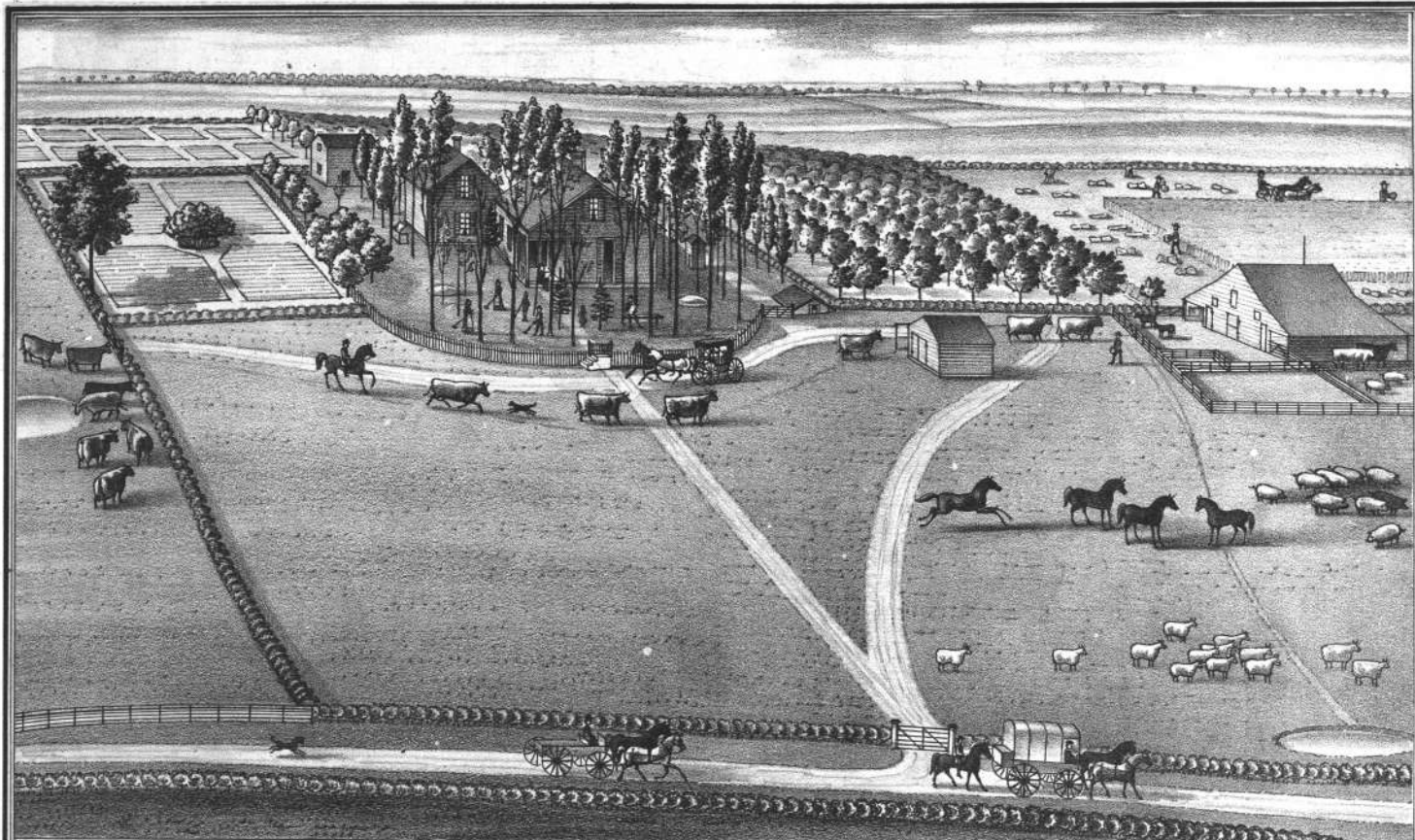

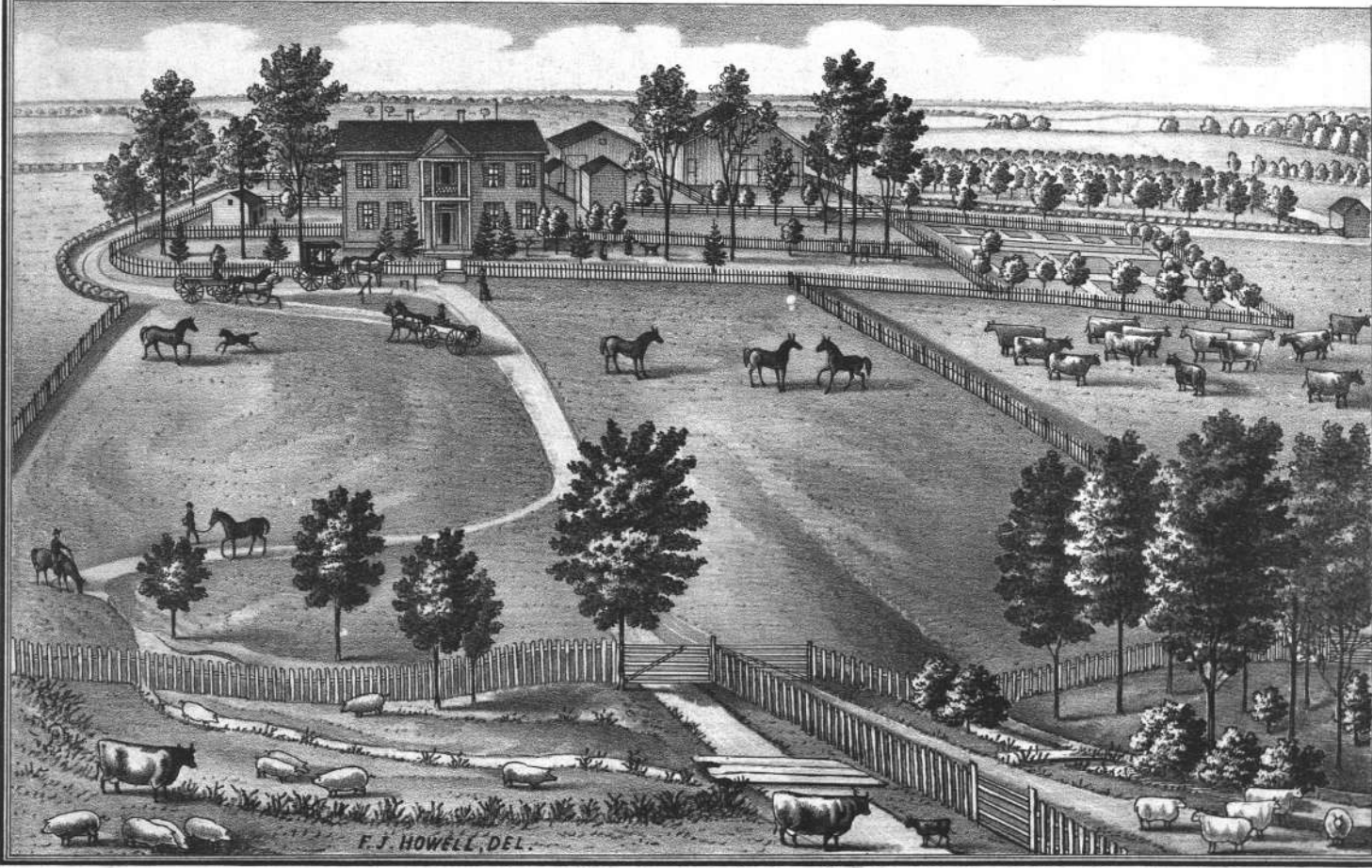

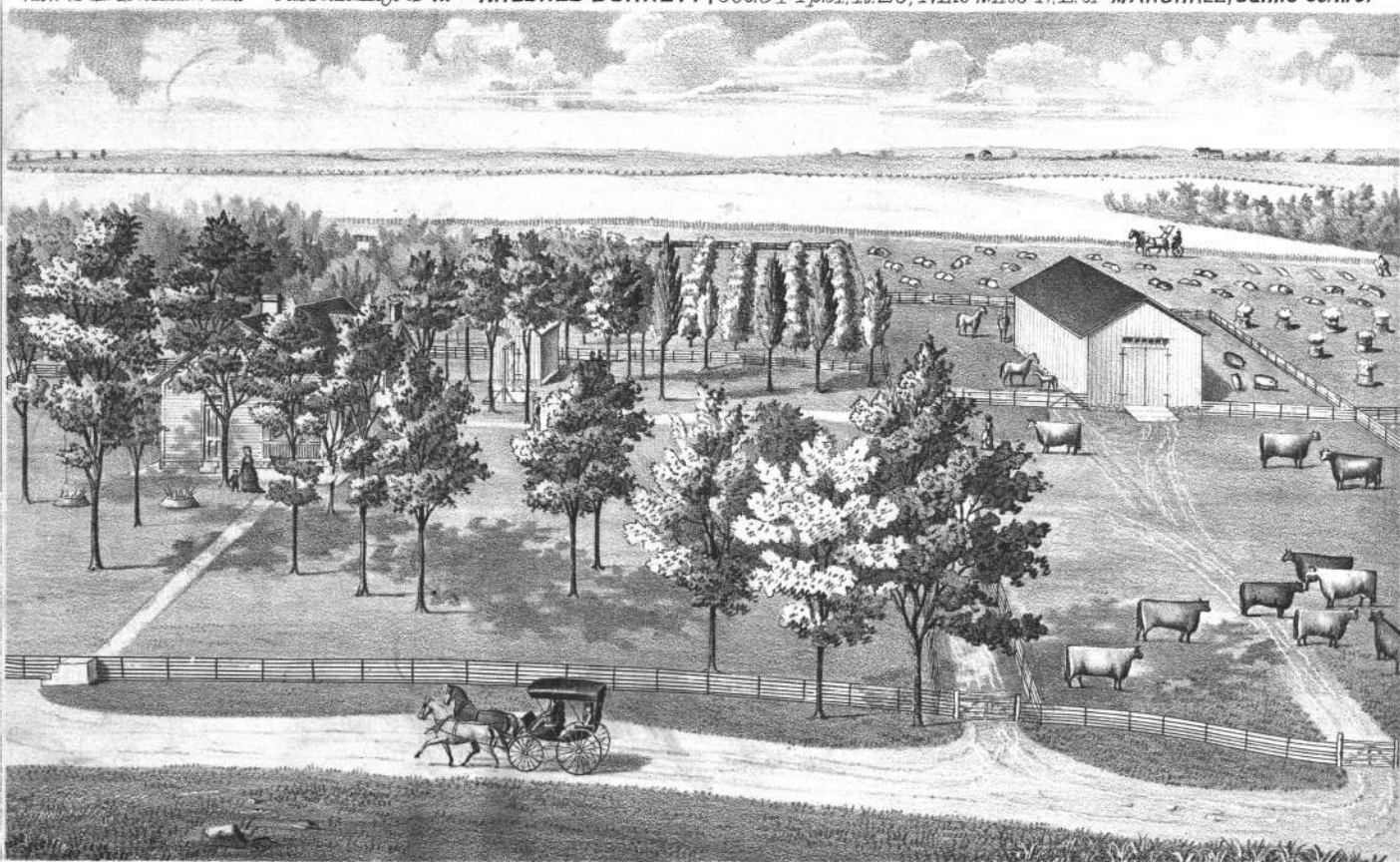

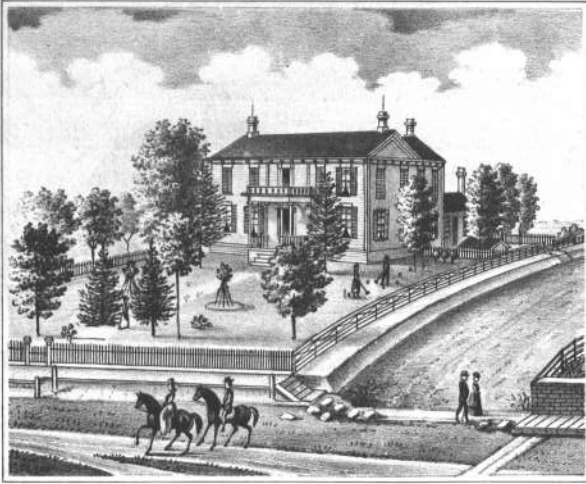

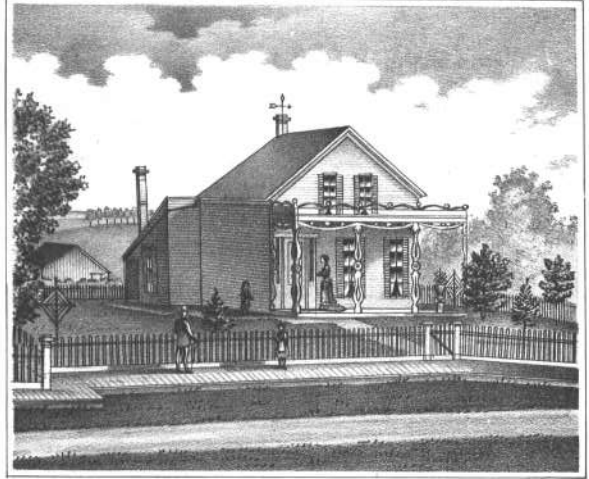

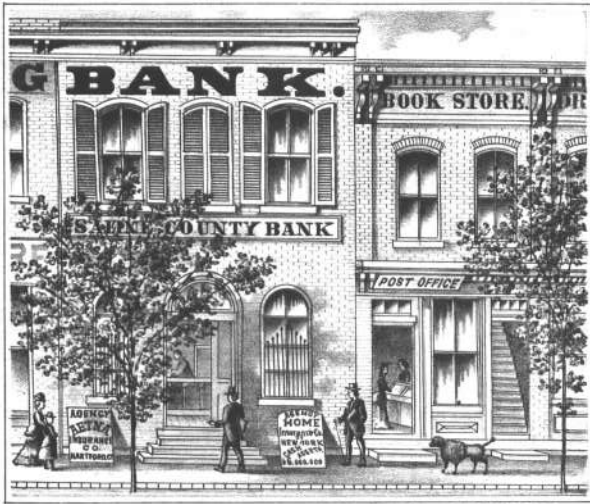

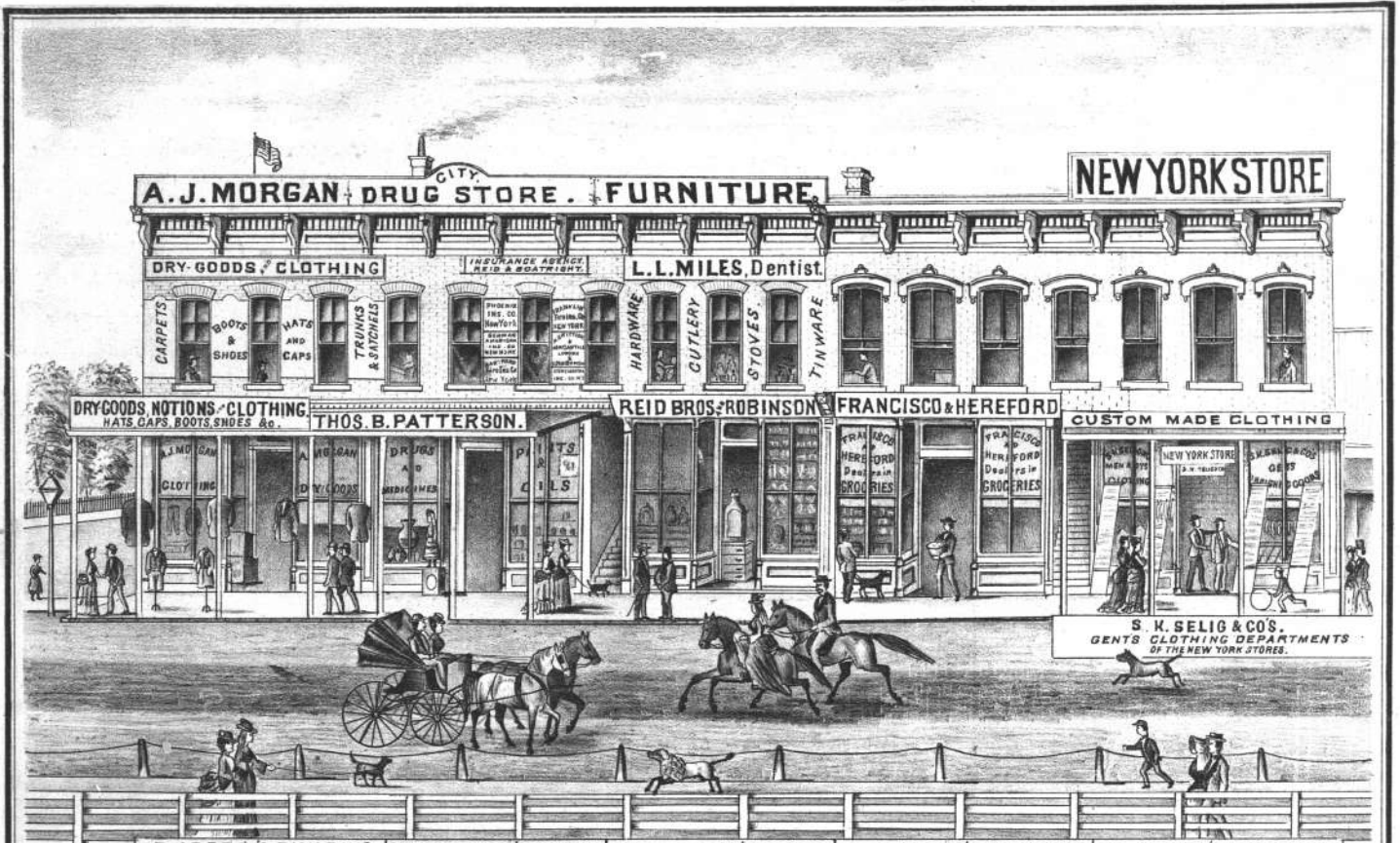

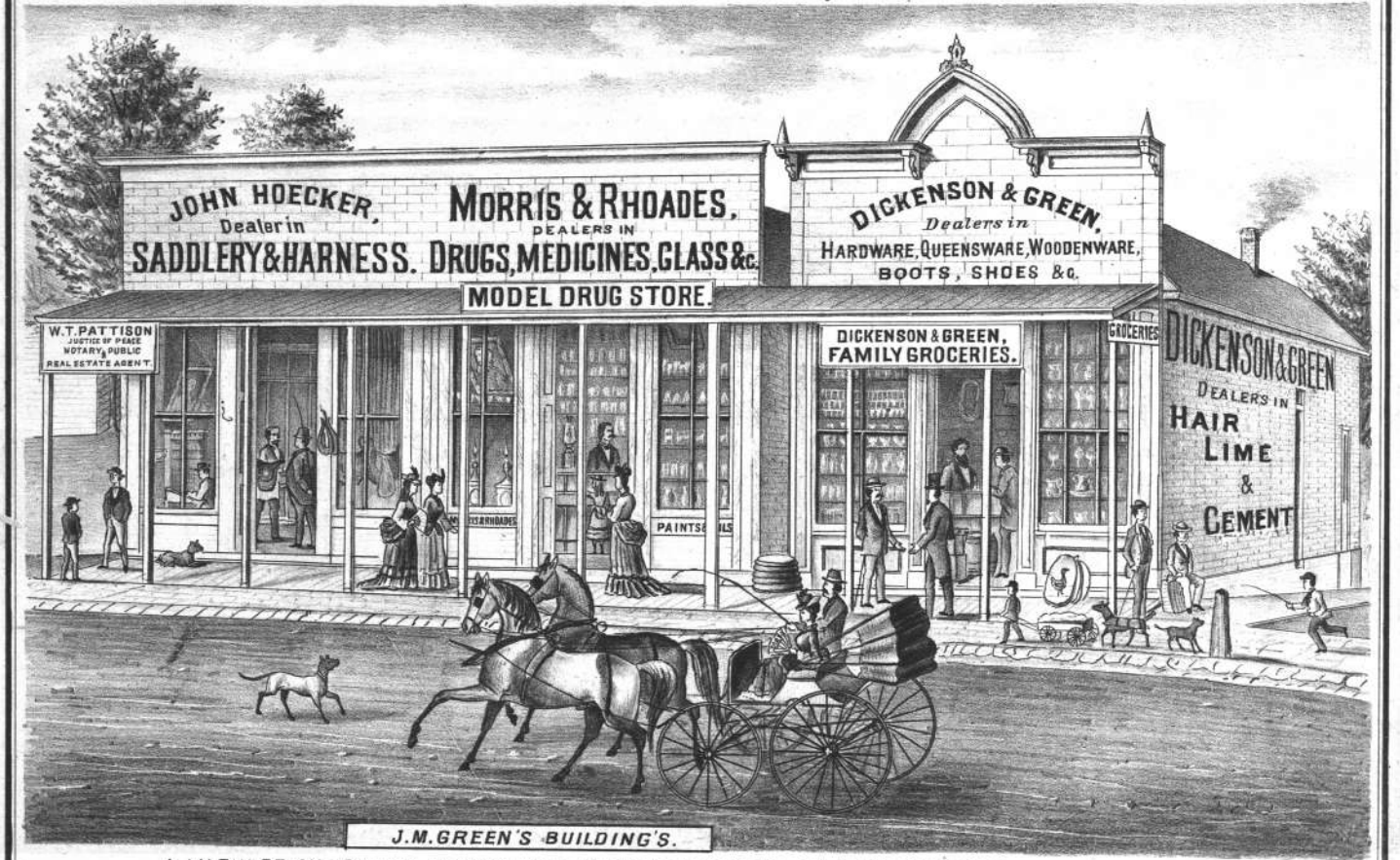

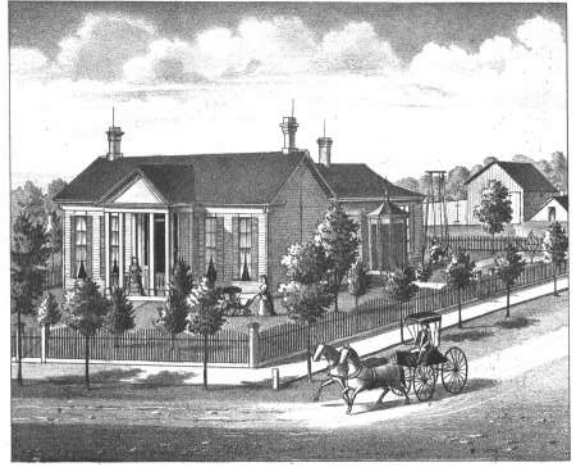

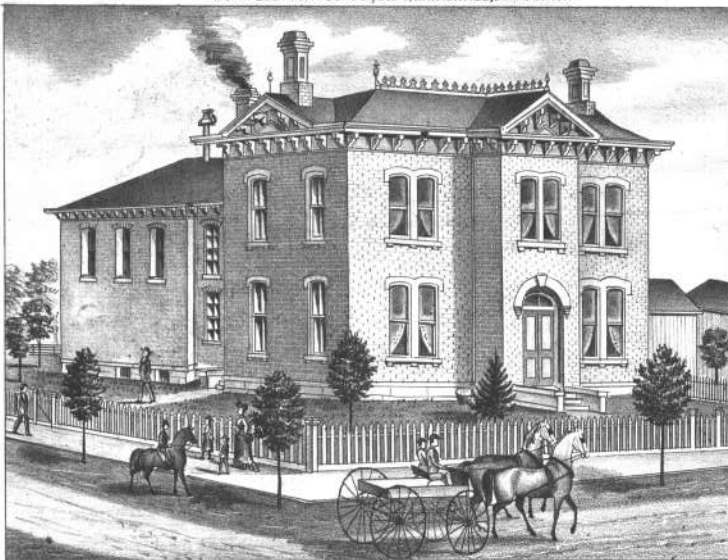

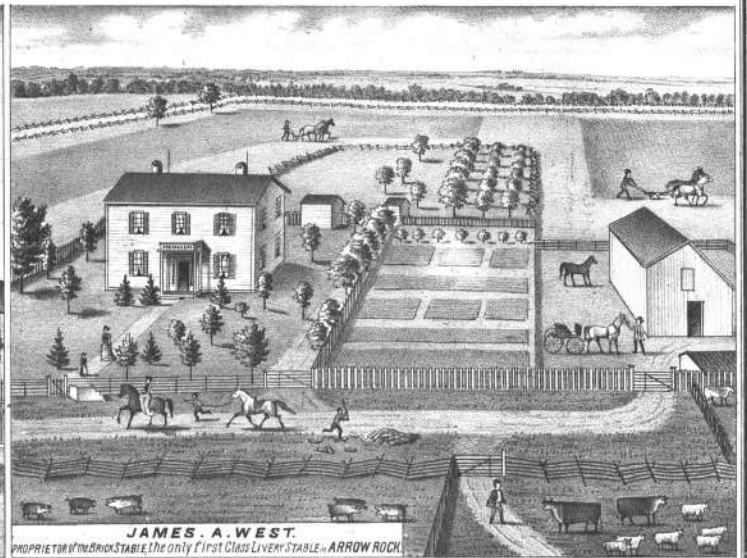
