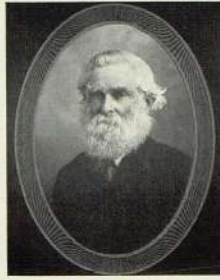

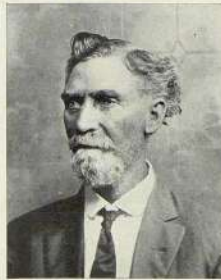

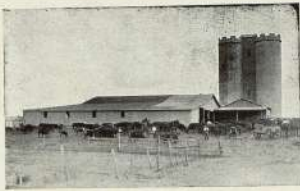

The cattle shed is 84 ft. x 114 ft. and has a capacity of
200 head of cattle, 7,000 bushels of corn, 75 tons of

and 67 ft. in altitude and has a silage capacity of
900 tons and will feed 200 head of big cattle for
