Enlisted in the Nineteenth Kansas Volunteer Cavalry in the fall of '68 and served in the Indian campaign under General George A. Custer, the following winter and spring. Came to Rock Creek in 1881 and established himself in the hay business there, and is still in the business; built the elevator and about a dozen other buildings. Has been twice appointed Postmaster by Presidents Harrison and McKinley.
