PROPERTY OF OAKLAND GENEALOGICAL INTRIBIDARYTION

When Lewis and Clark returned from their exploration of the western lands, their report to President Jefferson included a suggestion that the line of forts be extended into the district known today as Jackson County, Missouri. The explorers' suggestion was followed, and in 1808 the erection of Fort Osage (at times called Fort Clark) began on a headland on the south bank of the Missouri River. This was the land of the Osage, but the tribe entered into a treaty allowing the erection of the fort and setting aside the "Six-Mile" section around the fort for the support of the garrison. The life of this fort was short, but its place in the story of the Santa Fe Trail is assured.

The year 1825 saw the extinction of title held by the Osage and Kansas tribes to this part of western Missouri. The land was considered a part of Lafayette County until the county of Jackson was created in 1826. County government in Jackson County was set up in 1827. These dates are of importance in any study of the deed records. A few settlers had penetrated the Indian lands, but it is clear that title to land here could not be secured until the Indian gave up his rights and until the legal processes had been established in the county.

The deed books used in this compilation are the oldest preserved in the Recorder's office and are believed to be the originals. Every effort to decipher the old writing has been made. The original spellings have been

preserved, although some names are spelled differently today. In deciphering these names, written with the flourishes used in those days, interesting bits of information came to light. These appear here as Genealogical Notes. It is hoped that these and the Bibliography will aid in further searching.

The points listed here should be noted:

- (a) The index lists all names, but any given name is listed only once for a page. In other words, the entire page should be read.
- (b) All likely spellings of a name should be kept in I
- (c) All details considered of any value have been retained.
- (d) The user of these deed records would be greatly aided by a county map showing townships and ranges.

EDITOR'S NOTE: With the above deed, George C. Sibley enters the scene again. His financial troubles as they touched Jackson County land cover pages 213-227 of Deed Book B. Only the barest details can be given here. (See Appendix.)

Letter, Geo. C. Sibley to Wm. Russell: "Sir:...this found among my papers - Col. Easton asked for the deed." (St. Charles, Mo., May 10, 1828.) Note by Rufus Easton: "The deed asked for was from John Shrader and wife to Rufus Easton... for the same tract of land." (The New Madrid Co. Clerk adds a note that the land in question is recorded there in Book 10, pages 80 and 81. This Clerk was Richard H. Waters.)

John Shrader and wf., late of Big Prairie Twp., New Madrid Co., but now of Jefferson Co., Ky. - for 2400 dollars paid by Rufus Easton of the town of St. Louis, Territory of Missouri, sells 640 a. on Lake St. Francis in New Madrid Co., Mo., appearing on books of New Madrid County as owned by Jacob Myers...(land) had been injured by the earthquake and in accordance with the provisions of Congress (Act of Feb. 17, 1815) Myers was entitled to locate 640 a. on any Public Lands of said Territory of Mo.... "prior title was in one Jacob Myers, commonly called Prairie Jacque Myers, from whom John Shrader acquired title." Wit.: E. Baker and A. Gamble, both of New Madrid County. Acknowledged there on June 28, 1828, before Archibald Gamble, Clerk.

Rufus Easton says this concerns Certif. No. 497, dated

St. Louis, Dec. 8, 1818, to Jacob Myers - land in Sec. 32, Twp. 51, R. 29 - also Certif. No. 98 (dated 1816 and for 640 a.) to Jacob Myers (description here mentions "the old road, the big eddy in the Mo. River"...) "Abiel Easton is to hold the land during the natural life of her husband, Rufus Easton...who intends this land for the use of Abiel Easton and her children begotten by Rufus Easton..."

Memorandum by Rufus Easton, dated Jan. 9, 1823:-(He goes into his understanding of the complicated understanding between himself and George C. Sibley and Abiel Easton, who had used some of her own funds in all this.)..."Cottle's improvement near Fort Osage...the remains of Mr. Cottle's dwelling house..."

George C. Sibley, writing to Rufus Easton in 1821 and 1823 from Fountain Cottage, near Fort Osage...mentions Easton's "letter proposing an exchange of the Island for my lands at St. Charles...the Millirons, Mr. Barton...Mary and I...You and Joanna...Miss Abby..." (This complicated affair shows Sibley in financial difficulties which include a debt of \$12,000.00 to Wilson P. Hunt.)

Rufus Easton: (I intend)..."for my wife and youngest son, Henry C. Easton, 160 a. on the Island...my beloved son Joseph G. Easton is to lay off a town and call it Persepolis.. my beloved daus., Mary and Medora..." April 6, 1833. Wit.: John Lilly Jr. and L.C. Easton. Rufus Easton certifies as to the truth of the above statement in his capacity as one of the justices of the County Court, St. Charles County. (P.213-227)

APPENDIX

Benjamin Majors was the father of Alexander Majors, one of the originators of the Pony Express. In 1850, Alexander was still a farmer, aged 40, born in Tennessee. His household consisted of Catharine (aged 30, b. Tenn.) and these Missouri-born children: Rebecca aged 15, Elizabeth (12), Missouri (10), Flora (7), Benjamin (5), and James who was 2. (1850 Census of Jackson County, Missouri, page 521.)

Linville - The 1830 census of this county (p. 302) records families of Abraham, James, Thomas Jr., and Thomas Sr. Some of these were in Oregon by 1853. (See Oregon Donation Land Claims, volume 2.)

Eleanor McGee, aged 56, was head of a household in 1850 (p. 486 of census). With her were James H., aged 13, and two slaves. An interesting account of the McGee family, "inseparably woven with the history of Kansas City," is found on pages 272-274 of Vital Historical Records of Jackson County, Mo., along with records of burials at the McGee cemetery. A note there indicates that Amelia McGee, daughter of James and Eleanor McGee, married Wm. B. Evans. (This would explain the reference - see deed - by James and Eleanor McGee to "our son, Wm. Evans." Editor.)

Two Pool families are listed in the 1860 census of this county. Ann (52, b. Ireland) heads one, with four younger persons in it (p.277). James Pool heads the other. His age was 48, birth place in Maryland. With him were Sarah (40, born Tenn.) and Martha J., who was 7 and born in Mo.

Samuel D. Lucas, aged 51, is found on page 571 of the 1850 census with his family - wife, Therese B. (b. Ky.) and 5 children, aged 11 to 25 years. He is mentioned many times in <u>History of Jackson County</u>, <u>Mo</u>. He was still in the county in 1860.

Jacob Gregg, b. 1802 in Overton Co., Tenn., was a son of Harmon Gregg and his wife, Susannah Smelser. Dr. Josiah Gregg, author of Commerce of the Prairies, was another son of this pioneer family. (Road to Santa Fe, p. 245)

Lilburn W. Boggs, born 14 Jan., 1789, in Lexington, Ky., had a remarkable career before migrating (1846) to California. He was in Battle of Tippecanoe,...a merchant at Old Franklin (Howard Co., Mo.) after War of 1812. Became Governor of Mo. in 1836. (Road to Santa Fe, p.253)

Archibald Gamble, b. Winchester, Va., 1794, was a son of Joseph Gamble, Jr., and wife Anna Hamilton. On July 3, 1821, he married Louisa Easton, dau. of Rufus Easton, who had been the first postmaster of St. Louis. When Geo. C. Sibley's lands were sold, Gamble bought the site of Fort Osage and laid out the town of Sibley. Later, Gamble was

a trustee for Lindenwood College, which had been founded by the Sibleys. (Road to Santa Fe, p 19.)

George C. Sibley...appointed Government trader in 1808 by Thomas Jefferson,...was a son of Dr. John S. Sibley of North Carolina and Louisiana. G.C.S.was still there when Government trading was abolished fourteen years later. In 1815, George Sibley married Mary Smith Easton, aged 15, a daughter of Rufus Easton, first postmaster of St. Louis. (Road to Santa Fe, pages 1, 15.) Sibley is remembered also for his considerable part in early Santa Fe trade and as one of the commissioners selected by the U.S. Government to survey the Trail. His account of the mapping expedition into New Mexico is an interesting part of The Road to Santa Fe.

Samuel C. Lamme had stores at Franklin, Liberty, and Independence and was much involved in the Santa Fe trade. Indians killed him while he was on a trip from Santa Fe in 1828. ("Business Techniques in the Santa Fe Trade" by Atherton in Missouri Historical Review, vol. 34, pp. 335-341.) See also for the Aull brothers, Robert and James, whose business records are in the Public Library, Lexington, Mo. "Evidently James Aull called in loans as he had a big stock of goods and was obligated to business houses in the East for these goods."

"David and William Lamme were owners of probably the first paper mill west of the Mississippi River and certainly the first in Missouri..." (Boone Co., 1834.) (Missouri Historical Review, v. 27, p. 72.)

Doctor Smith was in the county by 1830. (1830 Census of Jackson County, Mo., p.307.) He was in the 20-30 age group; had four other persons in his household. (Was Doctor his given name? No physician named Smith appears in the census reports until 1860 (p.456) when Nathan Smith, aged 35, was counted at Sibley. It is unlikely that these are the same person. "Doctor" was probably not meant to indicate a profession. Editor.)

Edward Partridge was one of the advance "Saints" (Mormons) who prepared for their settlement in Jackson County. In August of 1831, he and others dedicated the spot in Independence where they believed a great temple would one day be built. When the Mormons were expelled (1834), Algernon Gilbert was allowed to remain as an agent to settle the business of those removing. (History of Jackson Co., pp. 252, 255.)

Joseph H. Reynolds became sheriff of Jackson County in 1840. He came from Lincoln Co., Ky. (Gregg, Road to Santa Fe, p. 241.)

"Col. John Thornton of Clay Co...eminent member of General

Assembly of Missouri for many years. His wife was Elizabeth Trigg, ... a dau., Jane, married (1837) Gen. A.W. Doniphan." (Annals of Platte County, Mo., p. 549.)

Joanna Abby Easton, a dau. of Rufus Easton, married Dr. Pryor Quarles. (Road to Santa Fe, p.265.)

Joseph C. Davis, assistant surveyor of Sibley's Santa Fe expedition, appears only briefly in Jackson County records. Most of his records are in Howard and Randolph Counties (Missouri) and in his diary, a copy of which is in the State Historical Society at Columbia, Mo. (Road to Santa Fe, pp. 240, 269.)

James M. Pool was a private in Co. A under Alexander W. Doniphan on the expedition into Mexico (1846). (Westport, 1812-1912, p. 36.)

John W. Moodie, aged 62 and Virginia-born, is listed as a landlord in the 1850 census (p.529). With him were Agnes (aged 36, b. England), Milton (17, a clerk, b. Missouri), Sarah (14), Robert (9), and 16 slaves. The household of J.W. Moodie, Jr. (a 23-year-old blacksmith born in Ohio) and Lavinia (18, b. Mo.) is also found on p. 529. (This younger J.W. Moodie is the subject of a biographical sketch on p. 876 of the History of Jackson Co., Mo.)

One William Moon can be found on p. 585, 1850 census. He was 66, a farmer b. in Tenn. With him were Catharine (50, b. Ky.), James (25, b. Ky.), Andrew (aged 12, b. Mo.), and Lucinda (b. Mo., 9 years old).

Various persons named <u>Everett</u> are found in early Clay County deed records. At the same time, Everett's Ferry linked Clay and Jackson Counties across the Missouri River near Independence. (Editor's files.)

The "Record of Deaths in the Catholic Congregation, 1846-1847" contains many of the French names found among a group that settled near the confluence of the Kansas (Kaw) and Missouri Rivers. Among these names are noted Laliberte as Montredie, the latter of which appears in the deed books Mo., pp 266-271.)

Joseph Harrelson, aged 40 and a native of Kentucky, is shown in the household of Zenos Leonard in the 1850 census with three young Heraldson (Harelson, etc.) children - Martha (aged 10), William (9), and Amanda, who was seven. (P.647)

At the Circuit Court held in March of 1844, Smallwood Noland executed a writ of emancipation for Frank, a black man of about 49 years. (Record Book E, p. 286.)

The Rev. Benton Pixley of Vermont and his wife were among the "family" of 25 adults forming the Great Osage Mission. The group established Harmony Mission near what is now Rich Hill in the present Bates County. One Samuel Newton from Woodbridge, Conn., was another member of this mission in 1821. (History of Bates Co., Mo., p. 54.)

A <u>Smallwood Noland</u> is listed on p. 15 of the 1840 census of Jackson Co. as 20-30 years old. <u>Smallwood V. Noland</u> appears on p. 22 of the same census, with the oldest male in the household being 40-50 years old. The 1850 census (p.568) has <u>Smallwood Noland</u>, aged 64, a Kentuckian, a farmer. (See also <u>Oregon Donation Land Claims</u>.)

The 1860 census shows Agnes Flournoy (aged 55, born in Ky.) as head of a household composed of Oscar (aged 23), Margaret J. (aged 18), William (5), Francis (aged 14 and female). Thomas (12) and Glover (9) were in other households. Just where these last three fit into the Flournoy families is not revealed in these census records. (See pages 157, 258, 272 of the 1860 census schedule.)

Walter Bales was the first of this surname to settle in Jackson County. His wife was Sarah Johnson, dau. of Thomas Johnson, missionary preacher who worked at Shawnee Mission, Kansas Territory. The 1860 census record of the children of Walter Bales (aged 57, b. Tenn.) and wife, Sarah (52, b. Tenn.) shows John (26), Samuel (22), Walter (18), Mary E. (16), James E. (13) - all born Missouri. Another son, William (merchant, aged 25), had his own household. (1860 census, pages 161 and 26.) This Walter Bales line stems from Pennsylvania Quakers who later went to Quaker meetings in North Carolina, Tennessee, and Ohio. Walter Bales came directly from East Tennessee. (Editor's research.)

Perman Henderson was in Oregon by Sept. 15, 1853. He recorded there his Tennessee birth (1801) and marriage to Sarah Trapp on 25 Dec., 1822-26 in Mo. (Oregon Donation Land Claims, Vol. 2, p. 62.) It is believed that the marriage to Sarah Trapp was in 1821 and that it was in Lafayette Co., Mo. Before leaving Missouri, he had acquired land in what is now Kansas City - between Troost, Lydia, 61st and 63rd Streets. This land was later in the hands of Boone Hays and Linville Hays. (Family history and notes from abstract of title - courtesy of Miss Nanon Carr.)

Stewart Lewis, b. May 29, 1800, was a son of James Lewis (b. N.C., 1767) and Elizabeth (Stewart) Lewis, dau. of John Stewart, Kentucky pioneer with Daniel Boone. By 1822, James Lewis and his family were in Jackson Co., Mo. Paxton's Annals of Platte Co., Mo. (pp.556-7) lists twelve children of James and Elizabeth Lewis, some settling in nearby counties - Daniel and Jesse in Platte Co., and Polly in

Lafayette Co. (For her, see 1850 census of Lafayette Co., where she is given as wife of Jedediah Williams.)

Early-day wagon makers: Lewis Jones, Hiram Young, John W. Modie. (History of Jackson Co., Mo., p. 646.) In the 1830 census, Jones headed a household with two other males (one under 5, one between 15 and 20) and five females (two under 5, one 5-10, one 10-15, and one 40-50 years old.) (Page 310 of 1830 Census of Jackson County.)

Dr. Kate Gregg says Richard Fristoe had a fish trap "where the Independence-Lexington road crossed the Little Blue, and at about the same time, Benj. Majors had a mill..."

(Road to Santa Fe, p. 251.)

After the Mormons had left Jackson County, a conference with them was held in Clay County in the summer of 1834. The ferry boat returning the Jackson County delegates sank and George Bradbury was drowned. (History of Jackson Co., Mo., p. 262.)

Barbara Carrick was a daughter of Annis Carrick and of Dr. Samuel Carrick, founder of the University of Tennessee.

After the death of the latter, these other Carricks followed their relatives (i.e., Samuel, Joel P., and Joseph R. Walker, etc.) to the Fort Osage neighborhood. (Editor's research in Knox and Roane Counties, Tennessee.)

At a Circuit Court held on March 7, 1828, Smallwood V. Noland and Sally, his wf., acknowledged a deed to James McKinney for land in Madison Co., Ky. (Circuit Court Record. 1822-33.)

Joseph Davis was enrolled as a practising attorney of the Circuit Court on March 28, 1829. (Circ. Ct. Record, 1822-33, p. 16.)

The first Grand Jury appointed in the Circuit Court (Nov. 30, 1827) included these early settlers: Ira Smith, Stephen Wells, Isaac Drake, James Conner, William Yates, John Blanton, William Johnston, Joab Powell, James Scott, John Young, James Parsons, Smallwood V. Nolen, John Pratt, Solomon Flournoy, James Blakely, Daniel P. Lewis, Benjamin Majors, James Lewis Sen'r, George T. Boys, William Silvers, James Shepherd, Joel P. Walker, Nathan Russell, John Patten. (Circ. Ct. Record, 1822-33, p. 4.)

These Baxters lived a mile or a bit more northeast of Independence, where today (1969) Baxter Road branches off from Kentucky Road. Families of Salathiel Butts and Williamson Hawkins (related) were in the same neighborhood. The last named was murdered in his home there in 1838. (Editor's files...from Circuit Court records.)

Flournoy - A Huguenot family found among earliest settlers

of Manakin on the James River (Va.) See "The Huguenot," pub. by The Huguenot Society, Founders of Manakin, No. 5, 1931. The early ones in Jackson County were from the Kentucky branch.

Samuel Weston - His will (Book L., p. 88 of Probate Court records) names son Robert, dau. Agnes Modie, dau. Sarah (wf. of Chas. E. Strode) and "my brothers James and Robert McCutcheon, my sister Nancy Nicholson, etc." (The life story of Weston is an absorbing tale, reaching from Europe to the frontier and involving a change in his name.)

Lewis Franklin - The pioneer settler of this family was his father, John Franklin, Sr., Revolutionary War soldier said to have been born in Chesterfield Co., Va. The family cemetery is at the side of Blue Mills Road (the first road laid out in the county) along which many of the early settlers took land. (Files of the compiler.)

Abraham McClellan - Presiding Judge of first County Court. From Roane Co., Tenn., he arrived about 1819 with kin named Walker, Toomey, etc. His wife, Jane, was sister to Joel, Joseph, John and Samuel Walker, all among earliest settlers around Fort Osage, near which these McClellans lie in Sibley Cemetery. A. McClellan was State Treasurer during term of Gov. L.W. Boggs. (Editor's research.)

Johnston Likins and Isaac McCoy are recorded in adjoining households in the 1830 census of Howard Co., Mo., p.167.

Lobb Cumberland Church - one of the oldest in Western Missouri, dating back to 1834. (K.C. Star, June 3, 1967.)

Joel Walker - first Justice of the Peace in the county; brother of Joseph Reddeford Walker, noted mountain man who showed Fremont the pass into California. Joel and his brother were pioneers into California, also. Earlier generations of these Walkers are the subject of Mrs. Emma Siggins White's Genealogical History of the Descendants of John Walker of Wigton, Scotland.

Isaac McCoy - Probably the most influential of the early missionaries of this frontier, and a man of many activities and talents. His journal and many volumes of his papers are among holdings of the Kansas State Historical Society. A short account of his life was presented in 1961 when the site of his farm was marked. (See Jackson Co. Historical Soc. Journal, issue of June, 1961.)

Rev. Jerome C. Berryman and wife Sarah (Cessna?) established Kickapoo Mission (1833) near Ft. Leavenworth, Kansas. He was also a government teacher. (Mo. Hist. Review 4-241)
