The original and each copy of an application for a passport must have attached to it a copy of the applicant's photograph. A loose signed photograph of the applicant must accompany the application.

The photograph must be on thin paper, should have a light background, and be not over three inches in size.

au-This blank must be completely filled out. The legal fee of one deliar, in currency or pastal manny etch, must accompany the application. A woman's application must state whether she is married or not, and a married woman must state whether she husband is a native clittee. The rules should be carefully read before mailing the application to the Department of State, Division of Passport Control, Washington, D. C.
