

# GENERAL SERVICES ADMINISTRATION RECORDS AVAILABLE IN SEATTLE

In preparation for his March meeting program on research in the National Archives, Harry H. Wrangham wrote to Phillip E. Lothyan, Chief, Archives Branch, Federal Archives and Records Center, asking for a brochure on holdings of genealogical interest. Here is Mr. Lothyan's reply:

Dear Mr. Wrangnam:

Thank you for your letter of February 23, 1973.

At the present time, we do not have a brochure or other printed information describing records in our custody. The following information may help to guide your genealogical research until such a pamphlet is available.

In general, the Federal Archives and Records Center contains some 250,000 cubic feet of records of regional offices of 84 Federal agencies in 400 locations in the States of Alaska, Idaho, Oregon, and Washington. Of this amount, some  $\varepsilon,000$  cubic feet are in the custody of the Archives branch as permanent records of the United States. Archival records are open to the general public but agency records require permission before they can be viewed or reproduced by the general public.

Most of our Archives Branch records are only of specialized interest to genealogists. Those of Indian descent will want to examine Bureau of Indian Affairs records, those whose forebearers were seamen may want to examine Bureau of Customs records, those Orientals whose parents encountered difficulties with immigration officials may want to examine U. S. District Court records, and those whose parents obtained land from the public domain may wish to use General Land Office records. The time span of the records open to the public date from the mid-nineteenth century to shortly after World War II.

The Seattle Archives Branch has the following rolls of microfilm for interinstitutional loan:

Oregon, 1850 (9 counties) Wasnington, 1850 (1 county)

Idaho, 1880 Montana, 1880 Oregon, 1880 Washington, 1880 Enclosed is a chronological list of microfilm publications available at all Archives Branches. Some publications may be of interest for genealogical researchers. You may request this film through your university library, four rolls at a time for 21 days.

In the near future, we will begin receiving microfilm of general population census schedules, 1790-1890. It will also be available through interinstitutional loan.

#### -- REPORT OF "GENEALOGY HERITAGE COUNCIL" MEETING --

Representatives of several Northwest groups interested in preserving historical and genealogical records, and in preventing duplication of such efforts, met in Yakima, Washington, on April 28, 1973. Mrs. Margaret Carver, a member of the Yakima Valley Genealogical Society, presided at the session, and Fred Carver acted as secretary.

A general discussion developed the general consensus that an organization of an informal nature was needed for the purpose of keeping the various groups informed of projects, such as cemetery records, etc., which have been completed, which are being worked on and which are planned for the future.

The group approved a motion "that an informal group be organized to include genealogical and historical societies and all other interested groups and individuals of work that has been done, is being done and is planned for future projects and that the information so gathered be disseminated to each member of the group."

A committee of five members was selected to prepare an organizational plan for the informal group and to select a proposed official name, submitting the plan to each group of record that may be interested. Those selected are:

Mr. Osburn Herd, Eastern Washington Genealogical Society, Chairman Mrs. Mary Horst, Daughters of the Pioneers of Washington Mrs. Frances Ehrig, Tri-City Genealogical Society Mrs. Sally Wright, Seattle Genealogical Society Mrs. Lilly Ehret, Tacoma Genealogical Society.

# --BOOK REVIEWS--

KENTUCKY FAMILY RECORDS, Vols. I and II, edited by Mrs. Edgar L. Cox, published by the West-Central Kentucky Family Research Association, P.O. Box 1465, Owensboro KY 42301. 8<sup>1</sup>/<sub>2</sub> x 11, loose-leaf, theme cover, indexed by surname. \$7.50.

These records are issued along with the West-Central Kentucky Family Research Association Bulletin, paged separately to be removed and combined into book form. When 100 pages have accumulated, a table of contents is prepared and an index made. Bible records, cemetery listings, census and court records, family records and letters, obituaries, and pension records are some of the excellent source material included. A real addition to any library's section on Kentucky. Exchanged for T.C.G.S. Indexes to 1850 Illinois censuses.

Beaver, Lowell J. HISTORIC MEMORIES FROM MONUMENTS AND PLAQUES OF WESTERN WASH-INGTON, no date, privately published. Available from Tacoma Genealogical Society, P. O. Box 11232, Tacoma WA 98411. 8<sup>1</sup>/<sub>2</sub> x 11, photo-offset printing, many illustrations. \$7.50.

Mr. Beaver's lifetime collection of miscellany about the Pacific Northwest was brought together in almost overwhelming quantity in this volume. Unfortunately, there is no index, and the table of contents is inadequate for finding desired information, especially surnames. Nevertheless, a wealth of important material has been preserved for those patient enough to search page by page. Exchanged for T.C.G.S. indexes to the 1880 Census of Washington Territory.

McLEAN COUNTY MARRIAGE RECORDS, 1831-1855, Bloomington-Normal Genealogical Society, P.O. Box 432, Normal IL 61761. Mimeo., 8<sup>1</sup>/<sub>2</sub> x 11, \$3.50.

This index is compiled from the records in the county clerk's office in Bloomington IL. Marriages for each year have been alphabetized according to the bridegroom's name, so that it is necessary to check 25 separate lists if the date of the marriage is not known, but brides' names are alphabetized in a single index. Thirteen marriages are also given from 1824 to 1829. They took place in what is now McLean County IL when it was part of Fayette, Vermillion and Tazewell Counties. Volume II of the Marriage Records is also being compiled. (Exchanged, with the book below, for the T.C.G.S. 1850 INDEX TO THE GALLATIN COUNTY, ILLINOIS, CENSUS.)

Clipping from the Kirksville MO Daily Express, Jan. 2, 1920:

# CENSUS TAKERS BEGIN WORK IN KIRKSVILLE

The Adair county census enumerators began their work this morning. There are six people at work in Kirksville. The town has been divided into six districts with an enumerator in each.

In the country, the township is the district unit. The number of enumerators varies according to the size of the township. Two people to the district is about the average.

Each enumerator carries a commission and a card. They are obliged to show this on demand, in order that they may be identified as bona fide census officials.

The work in the First Missouri Congressional District is in charge of Director Charles Sears, of Mason. The enumerators are allowed 15 days to complete their work.

The information to be obtained by the enumerators is covered by the following questions, which are asked on the printed census schedules:

Sex. Color or race. Age at last birthday Whether single, married, widowed or divorced. 65

Birthplace of enumerated, father and mother, with names of country and province if foreign born.

Occupation, specifying trade or profession. Also industry in which employed.

Whether attending school. Whether able to read. Whether able to write. Whether able to speak English. Whether home is owned or rented, and if owned, whether home is free of

encumbrance or is mortgaged.

Persons of foreign birth will be asked the following additional questions:

Year of immigration to the United States. Whether naturalized and if so the year of naturalization. Mother tongue or native language.

Census enumerators will call at every farm house in the county to secure information necessary to fill out questions contained in the agricultural schedule. Each farmer will be asked questions concerning the acreage and value of his farm, whether he owns, rents, or partly owns and partly rents the land he farms, the value of the buildings, machinery, and implements belonging to his farm; the quantity of all crops raised on his farm during the year of 1919, and many other questions covering all possible farm operations.

#### -- FROM OUR EXCHANGES --

THE SOUTHWESTERN GENEALOGIST, March, April 1973, p. 29 - An entertaiing article titled "Frontier Travel," worthy of careful reading and note-taking, by Barney C. Taylor, El Paso TX. In addition to describing the chief trails, he says,

But, what about the rivers? Many people seem to believe that the river boat was the main way to travel in those days. Sure, some people did float down the rivers on float boats; and some did travel on riverboats, but the riverboat has been played up as a means of frontier travel more than it really was. Put yourself in the place of the farmer going west to seek new land. He had with him in his wagon all his possessions, his work team pulled his wagon, his cows and chickens were with him; his wagon was not merely something to travel in. It was his work wagon for his new farm. Should he abandon all this to ride a riverboat? Or should he pay passage on a steam boat for all this weight to save a few days time? Usually the frontiersman was short of money and depended upon game along the trail for much of his food. If he used his wagon to travel and used the trails for roads, killing his game as he went, he could travel for very little money; if he bought transportation, he would pay dearly for it.
