T.C.G.S. purchase from the compiler, N. 4015 Marguerite Rd., Spokane WA 99206. 8^{1} x 11, mimeo, paperback, 29 pp. \$3.50. Deaths listed alphabetically, with date, age, sex, marital status, race, occupation, birthplace, place of death, residence, and sometimes names of parents, as well as cause of death. Separate index to other names in the entries.

Milner, Anita Cheek, M.A., NEWSPAPER GENEALOGICAL COLUMN DIRECTORY, Heritage Books, Inc., Bowie MD, 1979. 99 pp., reduced typewriting, hard cover. T.C.G.S. purchase.

Newspaper columns with emphasis on genealogy are listed alphabetically by state and include those contemplated, those now being printed, and many which are now defunct. As the author explains, back files containing columns no longer active may contain much important material. As far as possible, for each entry the author covers each columnist's byline and address, research area (counties) covered by the column, papers in which it appears and its frequency, requirements and charges for a query, and whether columns are compiled and/or indexed.

Lyle Perrigo has presented us with another of his well-documented, scholarly studies of the descendants of an ancestor. This volume presents five generations of Perrigos from the late eighteenth century to today, from Virginia through Ohio and Illinois to the West Coast and Texas. Citations to Federal Censuses, county histories, county deed books, probate records, and family letters give the account a solid foundation.

Photographs are particularly interesting, especially a three-generation one of the author at the age of three with his father, also Lyle Donovan Perrigo, then 53; and his grandfather, Asa Flint Perrigo (grandson of the Asa in the book's title) taken shortly before the grandfather's death at the age of 95. Several photocopies of documents are used, including two relating to the War of 1812 service record of the first Asa Flint Perrigo.

Appendices cover other families of the same or similar surname, research clues and leads, and other Perrigo family genealogists, with their addresses. A full name index completes the volume.

Sherman, Robert M, F.A.S.G., editor, MAYFLOWER FAMILIES THROUGH FIVE GENERATIONS, Descendants of the Pilgrims Who Landed at Plymouth, Mass. December 1620, Vol. II, General Society of Mayflower Descendants, Plymouth MA, 1978. xiii, 409 pp. hard-bound, fully indexed.

This volume covers the families of James Chilton, Richard More, and Thomas Rogers. It is indispensible in New England research. Given to the society by Evelyn H. Pratt, Doris D. Simmons, Ruth Kottwitz, Marie Bare, Gloria Brown, Margaret Rice, Carolyn Oster, and Columbia River Chapter, D.A.R.

-- NEW ARCHIVIST OF THE UNITED STATES --

ROBERT M. WARNER will become Archivist of the United States July 15, 1980, according to an article in the current Federation of Genealogical Societies NEWS-LETTER. Mr. Warner, 52, resides in Ann Arbor MI and is director of the Bentley Historical Library at the University of Michigan. He is a past president of the Society of American Archivists and is active in the Historical Society of Michigan.

Other organizations in which Mr. Warner has held leadership positions include the American Historical Association, the Organization of American Historians, the Michigan Academy of Arts, Science and Letters, the American Association for State and Local History, and the University of Michigan Research Club. He was a Society of American Archivists Fellow in 1967 and served as chairman of the planning committee for the Gerald R. Ford Presidential Library.

-- ANNE ELLIS MCELROY'S NOTES --

(Continued)

KEITH

LUCINDA KEITH was the daughter of JAMES and PHOEBE (Phebe) BENNETT KEITH. Both families are included in Dr. E. C. Smith's HISTORY OF LEWIS COUNTY and in Clark Sprigg's HISTORY OF WALKERSVILLE COMMUNITY.

From Dr. Smith's history: "Captain JAMES KEITH and DAN T. TURVEY emigrated to the same region immediately after the Collins settlement was established. Captain KEITH'S cabin stood on the south side of Calamus hollow a short distance above Jacksonville. He had the reputation of being by far the best hunter in all that section, averaging, it is said, fifteen or twenty deer a week during the hunting season. He was also one of the largest fruit growers in the West Fork Valley and years afterward his orchard was resorted to by the people of the neighborhood."

Mr. Sprigg writes: "The next year, 1800, the BENNETTS came over the old Seneca trail from the upper Potomac Valley, Pendleton County, Virginia, now West Virginia.. Mr. Bennett secured a patent for 2,800 acres of land adjacent to and including the present site of Walkersville. The Bennetts were fruit growers and propagated apples from seeds which they brought with them from the Potomac Valley. Mr. Bennett raised a large family of children, twelve in number, all of whom married and raised families . . . The third child, Phoebe, married JAMES Keith and doubtless received as part of her dowry the apple seeds from which grew his famous orchard."

When John and Lucinda married, they bought 150 acres of land on Canoe Run from her father, JAMES KEITH. It is interesting to note that Phoebe's youngest brother, Jonathan, was comptroller of currency for the State of Virginia during the Civil War. After the war he returned to Lewis County and practiced law.

Phoebe's younger sister, Abigail, married MATTHEW HOLT. Their great-grandson, Matthew (Mat) HOLT is presently (1978) County Surveyor of Lewis County, Weston, WV, and his wife MARY is County Clerk.

-- CHANGES IN LOAN POLICY FOR NATIONAL ARCHIVES --

July 31, 1980 will be the end of interlibrary loan requests by mail from the Seattle Branch and other branches of the National Archives. . . Interlibrary loan requests at the Seattle Branch are running about 1500 each week (one week it was 2000), as compared to 300 each week a little over a year ago. . . At present, about 40% of the census inventory is out on interlibrary loan at any one time. The Seattle Branch serves the Pacific Northwest and Alaska.

August 1, 1980 will be the day that the Ft. Worth TX Archives Branch will begin taking census interlibrary loan requests for the whole country. This will probably lead to a tremendous backlog of requests that will take several months for them to satisfy.

ADVANTAGE: The researcher who goes in person to the Archives Branch will have a much greater chance of finding all of his desired film in the drawers, instead of part of it out on loan.

DISADVANTAGE: For those who live at a distance from Seattle, more time may be

required for the Fort Worth Archives Branch to fill interlibrary loan requests. Do NOT write to the Seattle Archives Branch about this. The decision to change this policy was made in Washington DC.

Philip Lothyan, Director of the Seattle Archives Branch, has prepared Checklist #7, which includes non-census holdings of genealogical interest in the Seattle Branch which are unique to this branch, as well as materials that are common to all the branches. Checklist #10, which is being prepared, will' be a chronological listing of records which are unique to each branch of the Archives. This paper, on the branches of the National Archives, will be given at the World Conference on Records this summer in Salt Lake City and will probably be available for purchase from the L.D.S. Genealogical Society.

The idea of disbanding the National Archives in Washington DC and distributing them around the country is now a dead issue. It is heartening to note that the powers-that-be do listen when people get together and object to an announced policy.

-- LIBRARY OF CONGRESS/COPYRIGHT INFORMATION --

T.C.G.S. member Martha Berry Parker has given us a letter from her publisher, Ye Galleon Press of Fairfield WA, clarifying information which she volunteered at a recent Society meeting. According to her correspondent, the Library of Congress keeps the books which are sent to them for Cataloging in Process. He calls it ". . . a sort of free government service, the classification of the book according to the Library of Congress system. Some small town librarian can copy the C.I.P. information and make a library card or set of cards. . . As far as I know, books in the Library of Congress are not held in microfilm form. They keep the actual books there. . ." It is the books submitted for copyright, a totally different government agency, which may be "ash-canned" if return postage is not included.

-- ANCESTRY OF RUSSELL V. HALL --

(The following account of his lineage was submitted by Russell V. Hall, 1020 McPherson, Richland WA 99352. Mr. Hall, a new T.C.G.S. member, is in his eighties. The account is printed essentially as he wrote it.)

In 1976 I started writing a book on our Hall Family and Relatives. The Halls were known in England 900 years ago; before that time they were known as Fitzwilliam. One son did not like the name, changed it to Hall; after that he and his clan were known as Hall. After I am able to get a little more information on our Halls, will soon be able to finish the book.

Our ancestor Thomas, Susan and son George (age 13) came to Jamestown VA in 1620 on boat Bona Nova. He was a tobacco grower. Around 1638 he and his family moved to Manhattan Island NY. He was granted land along the East River by William Kieft, commissioner. It was near Turtle Bay. The United Nations Building is on part of that land today. William Kieft appointed him and seven other men as his advisors.

His son, around 1671, moved to Kingston NY. He was at that time appointed Commissioner of the Probate Court at Kingston. (I am going to write to the court house at Kingston to see if there are any records on him.) I would also like to know where he and his father Thomas are buried in New York.

Our great-great-grandfather Isaac Hall was born in Essex County NJ in 1758. His father was John Hall and his mother Magolina (sic) Gouverneur. John was born in Ulster County NY in 1703, Magolina in New Amsterdam (now New York City) in 1706. Note: There must be some discrepancy in these dates. It is highly unlikely that Magolina was 52 when Isaac was born. Her parents were Sarah Staats and Isaac Gouverneur. Sarah and her father, Dr. Samuel Staats, were born in Holland. Isaac Gouverneur was also the grandfather of the Hon. Gouverneur Morris, born in 1752, a member of the Continental Congress and one of the main founders of the American Constitution.

_Other relatives on collateral lines included four generals of the American Revolution, Lewis Morris, Van Rensselaer, Phillip Schuyler, and Israel Putnam.7

Our ancestor Richard Hutchinson's grandfather, Bernard Hutchinson, lived in York, England. Richard was born in Arnold, England in 1602, came to America in 1634, and settled at Salem Village, now Danvers MA. He brought with him the first plow in America. (I have a book on the Hutchinson Families by John Wallace Hutchinson, published in 1896, the year I was born. A picture shows Richard along with the plow and also his musket.) We are related to the Hutchinsons by our great-grandmother Polly (Hutchinson) Walton, wife of Abraham Walton. He was born in Amherst NH in 1777. His great-grandfather, the Rev. William Walton, vicar of the church at Seaton, England, came to America in 1635, first to Hingham MA. A son was born there in 1636. They moved to Marblehead MA in 1638. He helped build the first church there that year and was pastor there for 40 years.

His son Samuel Walton married Hannah Leach, who was born in Wenham MA. Her grandfather, John Leach, was a veteran of King Phillip's War of 1675. After the war, the governor gave land grants to all the veterans and their heirs. Samuel and a neighbor, Samuel Lampson; took advantage of the land grants. They went up to New Hampshire in 1734 and were the first two settlers of what is now Amherst.

Polly (Hutchinson) Walton's grandfather Solomon Hutchinson and his wife Hannah Putnam settled in Amherst soon after Samuel Walton did. He was the first town clerk. Solomon was born in Salem Village in 1721 and Hannah Putnam was born there the same year. Her father, Nathaniel Putnam, and Gen. Israel Putnam's father Joseph were brothers.

Great-grandfather Isaac Hall and his family came down the Ohio River in 1804 and took up a land grant in what is now Jennings County IN in 1810. We are from Greensburg IN.

HOW DO YOU FEEL? (Editorial Comment)

The "Genealogists' Code of Ethics," reprinted below, has been proposed by the Federation of Genealogical Societies, of which the Tri-City Genealogical Society is a member, for adoption by all its member societies as a part of local society by-laws, standing rules, and/or membership applications. To quote from the F.G.S. NEWSLETTER of September 1979: "It was felt that if we are to ask state legislatures to open vital records to genealogists, we should take steps to show that genealogists are worthy of this trust."

GENEALOGISTS' CODE OF ETHICS

In order to protect the integrity of public records and library books, I am ethically bound and hereby agree:

- (1) That I will treat with the greatest care and respect all public records and library books which may be made available for my use.
- (2) That I will speak with courtesy to all employees of a vital records office, or of a public library, when requesting to see any vital record or library book, and that when finished with such record or book, I shall express my thanks to the person attending to my requests.
- (3) That I will not tear, erase, mark or remove any public record or library book, and will refrain from mutilating, defacing or otherwise destroying any part of such public record or library book.
- (4) That when I have finished viewing any public record or library book, I will return it to the proper or designated place.
- (5) That I will not repeat or publish any item which will reveal the illegitimacy of any person born within the past 75 years.

This pledge is freely made by me upon penalty of forfeiting my membership in this society.

If it were to say "any information based solely on a public record or other printed book or document which will reveal the illegitimacy of any person . . ." I could sign it. In these times of "the new morality," whether we like it or not, children born of unmarried parents are becoming so accepted by society that before long it would be impossible to publish a complete family history without including some of these individuals. My own practice, in the four books which I have published, has been to use names and dates sent to me by the persons concerned, who are fully aware that they are giving me the information for publication. After that, if some reader with nothing better to do chooses to sit around counting months between marriage and birth dates, or comparing parents' and children's names, I'm sorry, but it's not my fault, and it's not the child's fault.

Please let me know what you think. Shall we make a fuss about this?
